Members Present: Casey Hall, Abby White, Kally Barnett, Danielle Grigsby, and Haley Egan

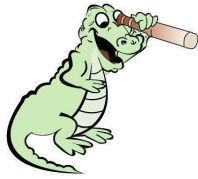
