## PARKING PERMIT APPLICATION

In order to insure the continued safety of the student body and staff, Berks Catholic High School has established the parking policy cited below. Please be aware that any student who intends to drive to school at ANY time during the school year must have the vehicle registered with the school office. Please read the following policy and if there is any intention of bringing a vehicle to school, please fill out the enclosed form and return it to Mr. Hess's office. Any unregistered vehicle parked on Berks Catholic property during school hours will be liable to penalties.

1. The fee for a parking permit is **\$50.00** for students. Please make check payable to Berks Catholic High School.
2. You must **show a valid driver's license** and car registration to purchase a parking space.
3. Vehicles must have insurance coverage with proof required.
4. If more than one vehicle is registered to the same family, and will be used, all vehicles must be registered with the administration.
5. Berks Catholic students will park in spaces to which they have been assigned. Vehicles parked on the city street in violation of local parking laws will be tagged by local officials.
6. Parking tags must be displayed and visible on the rear windshield of the vehicle
7. Students who do not use appropriate identification tags will be given an initial warning. Subsequent failures to comply will result in cars being towed at the owner's expense plus a possible loss of driving privileges to school.
8. All traffic signals and signs should be obeyed and a 10 mph speed limit should be observed while on school property
9. No offensive decals or inappropriate license plates.
10. Vehicles violating parking rules will be towed at the owner's expense.
11. Anyone using these premises assumes all risk of accident, and expressly agrees that Berks Catholic High School shall not be liable under any circumstances for any injury to person, loss or damage to property.
12. Students not following these rules will be subject to disciplinary action as set by the administration. This could be a warning or other penalties such as fines and/or loss of driving privileges to school.
