RESOLUTION TO RECONFIGURE FOREST ELEMENTARY AND KYLE ELEMENTARY INTO GRADE LEVEL BUILDINGS

The adoption of the resolution was moved by Mrs. Packard and seconded by Mr. Fox:

WHEREAS, the Troy City School District Board of Education is committed to the highest quality of learning to our students while making effective use of public funds; and

WHEREAS, a reconfiguration of Forest Elementary and Kyle Elementary will allow for more teacher collaboration, resulting in greater student achievement and growth; and

WHEREAS, a reconfiguration of Forest Elementary and Kyle Elementary will allow the district to operate these two schools at a lower cost to taxpayers;

BE IT RESOLVED that the Troy City School District Board of Education declares that beginning with the 2022-2023 school year, Kyle Elementary shall serve students in grades Kindergarten through second grade and Forest Elementary shall serve students in grades three through five. Both schools will continue to serve students in their combined attendance zones.
