The Ideal Candidate

- Has two years previous teaching swim lesson experience
- Demonstrates a passion for and patience with children
- Is enthusiastic and passionate about swimming, teaching and water safety
- Has experience with all swimming levels, from beginner to advanced, with experience working with both children and adults
- Is available Saturdays from 10 am-12 pm to teach group swim lessons
- Is ability to teach a minimum of two hours of private lessons on a weekly basis
- Holds current American Red Cross Lifeguard certification or ability to obtain certification within three months
- Complete all necessary pre-employment background checks and trainings
- Is aged 18 and older

Pay Range

- This is a part-time, hourly position, and pay will be commensurate with experience
 - Group swim lesson rate between \$13-\$20 per hour
 - Private swim lesson rate between \$40-\$50 per hour

Schedule/Availability

- Group swim lessons on Saturday from 10 am-12 pm
- Private lessons availability based on pool availability, yours, and families schedule
 - Main pool time: Saturdays after 12 noon; Sundays before 11 am or after 3:30 pm
- Instructors are paid on a per-client or per class basis and based on your schedule. You determine how many clients you would like to teach. This is an ideal situation for someone looking for supplemental income. This position could lead into coaching on a part-time basis.
