CLARIFICATIONS/QUESTIONS

***Please use the Revised Bid Schedule attached in you bid submission.**

QUESTION: In Section 2 Statement of work: 3 and 5- Can the project substantial completion date be moved to September 16 with final on September 23rd if the storm line to the clean out in the parking lot is completed before August 26th?

ANSWER: Yes, we can extend the substantial completion date.

QUESTION: In Section 2 Statement of work: 4 - Without an as-built drawing we don't know where the irrigation piping is so estimating breaks/strikes will be guessing at best. Can a line item be added for irrigation repairs on a per break basis or a T&M type number to cover repairs as they occur instead of trying to cover it in our lump sum price?

ANSWER: Please use the revised Bid Schedule attached.

QUESTION: In Section 3 Statement of work: 2b- Is there asbestos piping for the storm drain connection? Why would contractor need to be licensed for asbestos to bid this project?

ANSWER: You do not need to be licensed for asbestos.
