ADOPTION OF REAPPORTIONMENT PLAN A**

**A RESOLUTION REGARDING REAPPORTIONING SINGLE MEMBER VOTING
DISTRICTS FOR THE SCHOOL BOARD OF THE PARISH OF ST. MARTIN,
LOUISIANA, IN ACCORDANCE WITH THE 2020 CENSUS**

WHEREAS, The Census 2020 count has been completed and the PL 94-171 reapportionment data was delivered to the State of Louisiana on the 12th of August 2021, and,

WHEREAS, The St. Martin Parish School Board conducted a study which found the current districts were malapportioned and thereby required redistricting, and,

WHEREAS, the St. Martin Parish School Board has held several public redistricting workshops and has developed draft Plan 3 to meet the requirements of the applicable state statutes and.

WHEREAS, Draft Plan 3 is hereby formalized as the School Board's official redistricting plan and is designated as Redistricting Plan A; and,

WHEREAS, Plan A is contingent upon the precincts being approved by the St. Martin Parish Council in association with their adoption of Plan A on June 2, 2022.

WHEREAS, Redistricting Plan A meets all the requirements of the Voting Rights Act and applicable State Statutes; and,

WHEREAS, the St. Martin Parish School Board hereby authorizes the demographer to submit Plan A, hereby designated as the Reapportionment Plan to the State of Louisiana for review and implementation.

THEREFORE, BE IT RESOLVED by the St. Martin Parish School Board, in regular session assembled, that Resolution No. _____ adopting Reapportionment Plan A be adopted with the Districts described to -wit by whole or partial precincts:

PLAN A

Split Precincts in District 1

Precinct 10 (part)- (1) That part beginning at the point of intersection of Main Hwy. and Evangeline St., thence westerly to the abandoned railroad bed, thence southerly to Cypress Island Coulee Canal, thence easterly to Main Hwy., thence northerly La. Hwy 736, thence bearing easterly to the drainage lateral, thence southerly to Cypress Island Coulee Canal, thence easterly to Bayou Teche, thence northerly to a drainage lateral, thence westerly to the fence line, thence westerly to Olivier Lane, thence westerly to Main Hwy., thence southerly to the point of beginning and (2) that part beginning at the intersection of Main Hwy. and Port St., thence easterly to S. New Market St., thence northerly to E. Bridge St., thence easterly to N. New Market St., thence northerly to E. Madison St., thence westerly to Columbus St., thence northerly to Lelia St., thence northerly to Compromise St., thence westerly to Main Hwy., thence southerly to the point of beginning.

Precinct 16 (part) -That part west of the boundary formed by Nursery Hwy. and Section 28 Rd.

Precinct 15A (part)- That part east of Poydras Hwy.

Split Precincts in District 3

Precinct 10 (part)-That part west of the boundary from the intersection of Main Hwy. with Port St. thence northerly on Main St. to Cypress Island Coulee Canal, thence westerly to the abandoned railroad bed, thence northerly to Evangeline St., thence easterly to Main St., thence northerly to Olivier Lane, thence easterly to the fence line, thence easterly to the drainage lateral, thence easterly to the Bayou Teche.

Precinct 14 (part)-That part beginning at the intersection of Main Hwy. and Cypress Island Hwy., thence southwesterly, southerly, and easterly to Theobald Rd., thence northerly and easterly to Rousseau Poche Rd., thence northerly to True Friend Rd., thence northerly to Main Hwy., thence northerly to the point of beginning.

Split Precincts in District 4

Precinct 14 (part)- All of the remainder of Precinct 14 with the exception of that part beginning at the intersection of Main Hwy. and Cypress Island Hwy., thence southwesterly, southerly, and easterly to Theobald Rd., thence northerly and easterly to Rousseau Poche Rd., thence northerly to True Friend Rd., thence northerly to Main Hwy., thence northerly to the point of beginning.

Precinct 15A (part)- That part west of Poydras Hwy.

Split Precincts in District 5

Precinct 16 (part) -That part east of the boundary formed by Nursery Hwy. and Section 28 Rd.

Precinct 21 (part)- That part east of the power line right of way where it crosses Nina Hwy.

Split Precincts in District 6

Precinct 19 (part)- All of Precinct 19 with the exception of the area beginning at the intersection of W. Mills Ave. and the railroad tracks, thence easterly to Berard St., thence southeasterly to Ogden St., thence southwesterly to the railroad tracks, thence northwesterly to the point of beginning.

Split Precincts in District 7

Precinct 19 (part)- That part beginning at the intersection of W. Mills Ave. and the railroad tracks, thence easterly to Berard St., thence southeasterly to Ogden St., thence southwesterly to the railroad tracks, thence northwesterly to the point of beginning.

Precinct 23 (part)-All of Precinct 23 with the exception of the area beginning at the intersection of La. Hwy. 31 and Sugarland Dr., thence westerly to the Parish boundary, thence southerly to Interstate 10, thence easterly to La. Hwy. 31, thence northerly to the point of beginning.

Split Precincts in District 8

Precinct 24 (part)-That part east of Grand Point Hwy.

Precinct 29 (part)-That part east of the boundary beginning at the intersection of Cecil Watkins Rd. and Coteau Rodaire Hwy. thence northerly on Coteau Rodaire Hwy. to Moise Malliet Rd., thence easterly to Regis Lagrange Rd., thence northerly to N. Portage Hwy., thence northeasterly to the Parish boundary.

Split Precincts in District 9

Precinct 23 (part)-That part beginning at the intersection of La. Hwy. 31 and Sugarland Dr., thence westerly to the Parish boundary, thence southerly to Interstate 10, thence easterly to La. Hwy. 31, thence northerly to the point of beginning.

Precinct 27 (part)-That part north of the boundary beginning at the intersection of Bayou Teche and Mason Rd., thence easterly to Bushville Hwy., thence southerly to Alcide Bonin Rd., thence easterly to Coteau Rodaire Hwy.

Precinct 29 (part)-That part west of the boundary beginning at the intersection of Cecil Watkins Rd. and Coteau Rodaire Hwy. thence northerly on Coteau Rodaire Hwy. to Moise Malliet Rd., thence easterly to Regis Lagrange Rd., thence northerly to N. Portage Hwy., thence northeasterly to the Parish boundary.

Split Precincts in District 10

Precinct 21 (part)- That part west of the powerline right of way where it crosses Nina Hwy.

Precinct 24 (part)-That part west of Grand Point Hwy.

Precinct 27 (part)-That part south of the boundary beginning at the intersection of Bayou Teche and Mason Rd., thence easterly to Bushville Hwy., thence southerly to Alcide Bonin Rd., thence easterly to Coteau Rodaire Hwy.
