Mark Manz moved and James Foltz seconded a motion to approve and ratify the following modification of the contractual procedure for posting and filling of supplemental contracts under the negotiated agreement with the Paulding Education Association:

No supplemental positions will be posted for the 2021-2022 school year unless the person in the position resigns or the Board gives notice of intent not to renew by timelines in the collective bargaining agreement.

Starting with supplemental contracts for the 2022-2023 school year, if a supplemental position is held by a non-bargaining-unit member who has held the position for less than three years (counting the 2020-2021 school year), the position will be posted and filled in accordance with Article V, Section C, of the negotiated agreement between the Board and the Association, except that the Board will only award a position to a non-bargaining-unit member if there are no bargaining unit member applicants who apply timely and are qualified for the position (the phrase "and appropriate" will be deleted from Article V, Section C(3)(a)

Starting with supplemental contracts for the 2022-2023 school year, if a supplemental position is held by a non-bargaining-unit member who has held the position for three or more (counting the 2021-2022 school year), the position will not be deemed vacant and will not be posted. The incumbent will continue unless they resign or the Board notifies of intent not to renew by the timelines in the collective bargaining agreement.
