PARTICIPATION IN EXTRACURRICULAR ACTIVITIES
FOR NON-ENROLLED STUDENTS

Exempted Village School District Board of Education.

In order to participate in the Extracurricular Activity, student and his/her parent(s) and/or guardian(s) understand and agree that student shall be of the appropriate age and grade level for the Extracurricular Activity as determined by the Superintendent.

Student and his/her parent(s) and/or guardian(s) understand that this opportunity to participate in the Extracurricular Activity is only afforded by the Montpelier Exempted Village School District Board of Education to those individuals who are residents of Montpelier Exempted Village School District pursuant to R.C. §§3313.64 or 3313.65. Student and his/her parent(s) and/or guardian(s) acknowledge that his opportunity to participate can be revoked if the parent(s) and/or guardian(s) are no longer considered residents of the Montpelier Exempted Village School District. Any payment of fees shall not be refunded if the opportunity to participate is revoked.

Student shall only be permitted to participate in the Extracurricular Activity at the school to which the Student would be assigned by the District Superintendent if Student was enrolled in the District pursuant to R.C. §3319.01.

Student shall only be permitted to participate in the Extracurricular Activity if s/he fulfills and maintains the same academic, nonacademic and financial requirements that are required of all other participants for the Extracurricular Activity offered by Montpelier Exempted Village School District. Student shall abide by any and all applicable codes of conduct for the Extracurricular Activity. In the event that Student does not maintain the same academic, nonacademic and financial requirements for the Extracurricular Activity and/or does not follow the applicable codes of conduct for the Extracurricular Activity, Student’s opportunity to participate in the Extracurricular Activity will be suspended/revoked by the Superintendent. Any payment of fees shall not be refunded if the opportunity to participate is suspended/revoked.

Student and his/her parent(s) and/or guardian(s) agree that they are fully aware that there are special dangers and risks associated with participation in the Extracurricular Activity and other associated activities, including, but not limited to, the potential for falls, drops, slips, sprains, broken bones, extreme physical contact, or failure of proper equipment usage by other users. In

extremely rare cases, paralysis or even sudden death can occur as a result of participation in this Extracurricular Activity. Serious injury may also occur as the result of certain use of the equipment.

Montpelier Exempted Village School District and all others involved in this Extracurricular Activity have pledged to use every reasonable precaution to minimize the risk of injury to participants. Being fully informed of these risks and in consideration for being allowed to participate in this Extracurricular Activity, Student and his/her parent(s) and/or guardian(s) hereby assumes all risk of injury, damage, and liability arising from participation. In consideration for being allowed to participate in the Extracurricular Activity and receive benefits from such participation, the undersigned assumes all risks of accident or personal damage to his/her person or property; and hereby releases the Montpelier Exempted Village School District and its board members, employees, and volunteers, from any and all claims of personal injury, or loss of property arising from participation in any and all Extracurricular Activities. This release shall be binding on any heirs, administrators, executors and assigns of the undersigned.

I have read this Release of Liability/Informed Consent/Assumption of Risk Waiver agreement. I fully understand this agreement and that I have given up substantial legal rights by signing it. I sign it freely and voluntarily.
