- District Millage Rates are ranked in order of *highest to lowest* by the Total Residential/Agricultural rates.
- The Total Millage rate includes operating, emergency, permanent improvement, and bond levies, as taxed to homeowners.
- The EFFECTIVE Millage is the current rate a levy is at after the effects of House Bill 920. This 1976 Bill maintains the existing level of taxes paid by taxpayers on voted millage, regardless of increases in property values.
