# **FACILITIES SPECIALIST V**

# **QUALIFICATIONS:**

- (1) High School Diploma or equivalent.
- (2) Valid Florida Driver's License.
- (3) CDL (as required).
- (4) Demonstrate aptitude or competency for assigned duties.
- (5) Must have a minimum of eight (8) years verifiable experience or five (5) years verifiable supervisory experience in Facilities Management, or in one of the following work-related trades: Electrical, Mechanical, Plumbing, Security, Fire Alarm, Intercom, Low voltage, Locksmith, Building Management Systems (BMS) or Carpentry.
- (6) Required to have a valid card/license or equivalent certifications as applicable to a journeyman's level qualification.

# **KNOWLEDGE, SKILLS AND ABILITIES:**

Must be self-directed and knowledgeable of codes and regulations. Ability to organize projects and manage field personnel with their tasks or projects. Have proficient skills to read and understand blue prints and schematics. Technical knowledge of one or more of the above trades listed. Must hold and maintain the necessary licensing or certifications in the above trades. Person must have positive interpersonal and customer skills. Person must have proficient computer skills (i.e. Microsoft Word, Excel and Google.) and be able to learn the work order system and its functions. Experience to oversee a minimum of three (3) persons as directed by their supervisor.

Maintenance Supervisor, Coordinator, or Director (as applicable).

# **JOB GOAL**

To assist the Maintenance Supervisor and other District Employees, in the quest to provide students, teachers, and staff with safe and healthy buildings in which to work and learn. To help maintain the facilities throughout the district.

#### SUPERVISES:

As assigned.

#### PERFORMANCE RESPONSIBILITIES:

- \*(1) Perform tasks and duties on an individual basis.
- \*(2) Assist Maintenance Supervisor in the performance of his duties as needed.
- \*(3) Provide training for Facilities Specialists I, II, III, IV's and V's and/or temporary employees.

#### FACILITIES SPECIALIST V (Continued)

- \*(4)-Proficient with the work order system (create work orders, print out, distribute to personal and close out as needed).
- \*(5) Oversee small, medium or large projects (i.e. man power, materials, schedule as needed).
- \*(6) Proficient knowledge of drawings and schematics for troubleshooting or installation.
- \*(7) Estimate material and labor for jobs.
- \*(8) Maintain a truck inventory.
- \*(9) Examine school buildings and grounds on a regular basis as directed.
- \*(10) Prepares work schedules for jobs and monitor progress.
- \*(11) Attend meetings, seminars, and in-service programs.
- \*(12) Coordinate with Supervisors, Project Managers, Coordinators, and Director of Plant Services.
- \*(13) Operate and maintain equipment and tools to perform job.
- \*(14) Maintain a working knowledge of methods, materials and equipment needed to complete tasks.
- \*(15) Receive and account for materials and supplies as directed.
- \*(16) Maintain necessary parts inventory.
- \*(17) Ability to diagnose/troubleshoot system problems.
- \*(18) Determine necessary tools and parts needed to complete assignments.
- \*(19) Make deliveries and transport goods as needed.
- \*(20) All phases of grounds maintenance (i.e. cut grass, trim hedges, trees, bushes & weed control).
- \*(21) Perform maintenance functions independently, including but not limited to the following:
  - Electrical repairs (i.e., Proficient in replacing ballast, receptacles, light bulbs, troubleshooting electrical systems and circuit boards, bending pipe and knowledge of wire sizes, etc.) Knowledge and understanding of building codes.
  - Plumbing repairs (i.e., Proficient in replacing fixtures, water lines, troubleshooting plumbing systems, repairing and soldering of copper pipe and using plumbing snake to clear drain lines, etc.) Knowledge and understanding of building codes.
  - Air Conditioning repairs (i.e., replace filters, clean condensation drains, proficient in investigating problems and troubleshooting, etc.) Proficient in all phases of Energy Management Systems (EMS), Knowledge and understanding of building codes. EPA 608 Type Universal.
  - Fire Alarm Intercom Fire Alarm System Agent/Burglar Alarm System Agent Certified.
  - General Proficient in repairing windows, doors, laying out walls and providing material list. Knowledge and understanding of building codes.
- \*(22) Must be willing to be cross-trained in all trades and train other personnel.
- \*(23) Maintain safe work environment.
- \*(24) Be available for scheduled shift work.
- \*(25) Ability to be on call, when needed.
- (26) Perform other tasks consistent with the goals of the District as assigned by the maintenance supervisor.

# **ENVIRONMENTAL CONDITIONS:**

Work both indoors and outdoors in a noisy, high heat/humidity and cold environments. Requires exposure to possible bodily injury from electrical shock, falling from heights, and blood borne pathogens.
