

FISD School Safety Advisory Committee

June 8, 2022

Welcome - Mr. Roher welcomed everyone to the meeting and reiterated the purpose of the committee - reviewing the history of the committee: key decisions, safety layers from previous meetings, and again the purpose of the committee.

1. Review and Feedback discussion - Off-Site Reunification at the Harbor Church on May 23rd, 2022.

Mr. Patton led a discussion on the off-site reunification drill that took place on May 23rd. This was a drill with parental consent for fifth graders at Windsong. The students were bused to the Harbor Church where parents picked them up. Chief Weiners provided a summary of the drill from both an operational point of view and discussed FPD response. Chief Weiners said the drill ran well. Mr. Patton reviewed key points of feedback from the drill and thinking points going forward: Greater accountability of staff (beyond sign in sheet), distribution of car placards at the beginning of the year for key staff members, additional staff at emergency contact station, scalability, additional data entry tent, additional officer at emergency contact station. Staff and city officials will make alterations to the reunification plan based on the drill. Next steps are evaluation of Off-Site Reunification Plan with feedback from FPD and Office of Emergency Management over the summer.

2. Review of Current Safety Layers, Training and Protocols.

Mr. Patton discussed several new things added to safety layers for this year. We have added police officers at non UIL large events. We have also added additional training for the security monitors on teachers in service days in coordination with FPD - utilization of cameras by security monitors to track a mock suspect while SROs/FPD move throughout the school to locate the intruder/mock suspect (with radio use). Mr. Patton reviewed the newly installed visual alert system and discussed how the system will work in the event of an emergency. Chief Weiners and the committee also discussed several other physical securities as well as continued safety training for staff via a partnership with FPD. Mr. Roher then reviewed several partnerships FISD has to help students and families with social emotional needs. Committee members discussed Safe and Secure Campus teams and how they support the campus and can continue to improve. They also discussed current layers and the importance of continuing to be vigilant on important aspects on campus. Mr. Patton then discussed mock intruder drills from the 2021-2022 school year, and getting students, parents, and staff to be vigilant about not opening doors for people from the outside. He also discussed continuing with reunification drills. Mr. Patton also reviewed some of the safety tools currently in use like the Group Me, See Something Say Something, radios, etc.

3. Feedback Discussion - Recommended Health Mitigation Protocols 2022-2023

Mr. Patton discussed the current health mitigation protocols. He emphasized if the state does not dictate protocols for COVID, the District will manage COVID protocols in a similar way to other illnesses (due to feedback from health care professionals and FISD nurses). This would include fever free and improvement of symptoms.
