## Day 1 Restorative Leadership

Day 1 will provide educators in leadership positions with a clearer understanding of how to align concepts of Restorative Practices (RP) within their role.

Topics include: Communicating the restorative message, the restorative leadership model, empowering vs. oppressive leadership, how to model RP within your site's culture, and strategies to strengthen all stakeholders' sense of honor and value.

# Day 2 Sustainable Restorative Practices Site Implementation

Day 2 will provide educational leaders with an overview of the necessary components for their site(s) to sustain the work of developing a restorative community,

Topics include: developing an RP leadership team, involving students as restorative leaders, providing ongoing professional development, coaching and support for staff to be successful, how to model restorative practices within staff communication and meetings, developing policies that build a restorative community, and how to communicate the restorative vision with parents/quardians.
