# **Board revises drug testing policy**

The Board unanimously approved a revised drug testing policy for 7th–12th grade students who participate in extracurricular activities, including parking on campus. The new policy, according to Superintendent Charlie Alderman, focuses on parental awareness and will be used as a vehicle to deter drug use.

Administrators will hold meetings in September with students in the testing pool and their parents to explain the process, procedures and consequences of a positive test. Parents will be asked to sign a drug testing authorization.

Testing will begin in October for all students in the testing pool. Random testing will be conducted once every nine-week grading period.

Consequences range from a 14-day suspension from activities and community service for a first offense to suspension from activities for one calendar year for a third offense. Students will be allowed to practice with their teams during suspension.

Counseling and education are the cornerstone of the program, according to Alderman. Texas A&M University-Commerce will offer drug counseling for students that test positive.

Dr. LaVelle Hendricks, associate professor in the Department of Counseling at TAMU-C and also a CISD Board member, and other certified drug counselors will offer the counseling component of the program, which will be conducted at no cost to the district or student.

The first CISD drug policy was instituted in the 2013-2014 school year but not used after that time. Due to issues with the former testing company, CISD will be using a new testing company.

## **District receives C accountability rating**

TEA released district ratings from its A-F accountability measures for 2017–2018. Commerce ISD received a C rating, which TEA Commissioner Mike Morath said was proficient. All campuses met standard.

Superintendent Alderman said the ratings were directly related to the socio-economic level of each district. Districts receiving A's have a high socio-economic level and those with a low socio-economic level received D's and F's.

Leading the public hearing on ratings, Assistant Superintendent Dr. Patricia Tremmel said that principals already have plans in place to address issues surfacing in the recent STAAR testing results, including additional training on understanding ratings and scoring.
