## **Robinson named Curriculum Director**

The CISD Board of Trustees named Julia Robinson Director of Curriculum, Special Programs and Grants at its regular Board meeting on January 20. Robinson replaces Danna Myers who resigned to accept a position at the Region 10 Education Service Center.

Robinson will remain principal at A. C. Williams Elementary for the remainder of the spring semester. A search for her replacement will begin later in the spring.

## **ACW architect says weather, holidays delay progress**

Claycomb Associates Architect Nathan Morgan told Board members that even though bad weather and the holidays slowed progress on the new ACW building, workers could catch up and get back on schedule. He said that the remainder of the slab should be poured by the end of this week and the exterior brick work would begin on area A, the large cafeteria/auditorium section. The installation of skylights has begun in the classroom wings and most of the concrete has been poured around the building. Workers will begin roofing soon.

## **Board approves technology purchases**

After a lengthy explanation by Al Shipp, the districts' technology director, Board members voted unanimously to purchase technology for the E-rate project at CES and also approved the purchase of technology for the new ACW school.

As a 90 percent economically disadvantaged school, CES should receive the E-rate funds which will enhance and upgrade technology across the District. If the entire \$733,000 project is funded through E-rate, the district cost would be approximately \$200,000 over three to four years, according to Shipp.

## IN THE *Superintendent's report...*

The Board heard enrollment dropped to 1616, down three students from last month. Nine students left the elementary campuses while the ins and outs of students at the secondary schools left a six-student gain.

Filling is open for the Board of Trustees election from February 9 through March 9 at the Administration Building.

Place 6, currently held by Debbie Aikin, and Place 7, held by Medley Wilson, are up for election.

Cooper said he had been answering questions about UIL district realignment in recent days, most recently at a Lion's Club meeting. Under current rules, the District is only nine students above the cut off for 2A schools. Enrollment in October will determine the District numbers used in the realignment. The enrollment count for the different classes could also be adjusted for the February 2010 realignment, according to Cooper.
