
# Understand the Impact of the 1% Earned Income Tax on District Finances...

from Dan Levengood, Northwest Local Schools Treasurer

As recently as five years ago the financial future of Northwest Local Schools was very bleak. The school district had been put into Fiscal Caution by the Ohio Department of Education, and the district took steps to reduce spending obligations to a bare-bones minimum. Recognizing the need to save the district, the Northwest community passed a 1% earned income tax in May of 2010. The passage of this issue removed the school district from State Fiscal Caution and allowed it to pay off its debt, upgrade unsafe equipment and outdated technology, and strategically plan the best education for all students.

Now Northwest Local is facing a different kind of hurdle. The Five-Year Forecast for Northwest Local Schools is greatly impacted by our anticipated revenues. The forecasting of our State Foundation money is reduced significantly due to our dependence on what the state calls the Transitional Aid Guarantee. The Transitional Aid Guarantee is a payment provided to school districts whose enrollment has dropped in recent years. Like many school districts in Ohio, Northwest has been dealing with declining enrollment. In the last four years, our enrollment has dropped by approximately 250 students, and State Foundation money is largely based on the number of students attending the district. The Transitional Aid Guarantee, which provides us with an amount of financial aid as if we still had the same enrollment, is the state's way of helping districts deal with reduced income. Although some form of this aid has been in the budget for many years, it may be discontinued in the next year. I have included in the forecast a reduction in state aid because of the uncertainty of the Guarantee's continuance. The next Ohio Biennial Budget will be presented early in 2015, and the state's decision to continue or to end the Transitional Aid Guarantee will be very important to Northwest Local Schools.

The second very impactful revenue source in this budget and forecast is the renewal of the 1% earned income tax. The earned income tax has provided Northwest slightly over 15% of our total revenues in fiscal year 2014. Failure to renew this revenue source would greatly impact the education we provide to our students. The Board of Education will have many tough decisions to make if the levy is not renewed. To balance our budget if the levy is not renewed, we must face some tough decisions: 1.) reducing upwards of 40 staff members; 2.) reducing class offerings and staff; or 3.) reducing class offerings, extracurricular activities and staff.

Passage of the earned income tax would allow us to maintain our present programs. We now provide a very good educational opportunity for our students in some of the best facilities in the county. The recent Ohio Department of Education Report Card showed that our students performed very well on the Ohio Assessment Tests. We should be proud of the efforts of our students and teachers. It would be difficult to accept something lower due to the defeat of renewal levy.

### **KNOW THE FACTS**

- The 1% EARNED income tax is not permanent.
- The RENEWAL period is 5 years.
- \$2.3 million is raised from the RENEWAL.
- Property tax would need to be 9.75 mills in order to raise \$2.3 million.
- If the 1% EARNED income tax is not renewed, programs, extra-curricular activities and staff will be cut to balance the budget.
- This RENEWAL maintains present programs. It doesn't create new programs.





#### Northwest Local's 2013-2014 Report Card Released

On September 12th the Ohio Department of Education released the 2013-2014 state report cards for all school districts in Ohio. The state report card format assigns a letter grade of A to F to each identified component of the report card with the letter grade C being equivalent to the previous Excellent rating. Letter grades were assigned in the areas of achievement, progress, gap closing, and graduation rates.

Northwest's report card reflected significant gains in the areas of progress, gap closing and the 5-year graduation rates. Overall the district earned six A's, two B's and one C. The district will continue to evaluate the data, monitor student progress,





#### **Third Grade Reading Guarantee**

School districts are required to annually evaluate students in kindergarten through third grade by September 30 to determine if they are reading as well as they should be. Students are on-track if they are reading at grade-level based on the previous end-ofyear standards' expectations. A student identified as not-on-track is not reading at grade level based on previous end-of-year standards' expectations. The district is currently in the process of reviewing the diagnostic evaluation data to determine which students will need to be placed on a reading improvement and monitoring plan (RIMP), which will address the student's individual reading needs. Students will be monitored throughout the year to ensure their reading skills are progressing. Northwest offers various interventions for students identified as noton-track, including Title I tutoring, an after-school reading program, differentiated small group instruction and summer school. We encourage parents to take advantage of these options.

#### **Advancing to Fourth Grade**

Except for students with special circumstances, students must meet a minimum score on the state reading test to move on to fourth grade. During the 2014-2015 school year, a student must score 394 for advancement to fourth grade. The students will have two opportunities to attain this score, the fall and spring administration of the Grade 3 Reading OAA. If you have any questions regarding your child's progress, please contact their classroom teacher or building principal.

### **Standards-Based Report Card Initiative Update**

Northwest Local has utilized a standards-based report card for students in kindergarten through second grade for several years. During the 2013-2014 school year, we began exploring the option of expanding the use of the standards-based report card to include students in third through fifth grade. The district decided to phase in the standards-based report card so that none of our students would move from traditional grades to a standards-based report card. The first phase of the project involved the Northwest Primary staff revising their existing standards-based report card to reflect Ohio's New Learning Standards and implementing the updated report card during the 2013-2014 school year. This year a standards-based report card will be implemented in third grade. During the 2015-2016 school year, fourth grade will begin using the standards-based report card with fifth grade implementation the following school year. 

### **MEET the CANAL FULTON ARTS COUNCIL**




