Northwest Community Plans for the Future

For three days in December, 29 educators and community members met to plan for the future of the students of our district in a process facilitated by Ohio School Boards Association consultant Kathy LaSota. Superintendent Bill Stetler explains the reason for long-term planning: "A strategic plan answers this question: What will the children, in 10 years, thank you for? Up to this point, our decisions have been driven out of desperation financially. We've now got the boat afloat, and, that's OK, but it doesn't take you anyplace, so you have to direct it where to go."

The committee was represented by a cross-section of the community, not all of whom agreed with school district's decisions over the years. One of those individuals is Ken Gabbard, who changed some of his opinions after serving on the committee:

"I was bitter toward the school district and the things we were giving up while I was paying a lot of taxes. More levies were coming up, and as a citizen I felt like I was giving and not receiving. For example, I asked if giving up busing was a good decision. Were the board members being good tenants of our money? I had a chance to meet the teachers and the principals through being on the strategic planning committee. I

"I feel like our money was being maximized after meeting with these people. Sometimes I don't know if we have anyone representing us anywhere, not just with the schools. But with the school system, I have an admiration for Mr. Stetler. He has the backs of his teachers, and the people working with him are people wanting to do the finest job. I believe he is committed to training the teachers to do their best to give our children a quality education." ...continued on page 5

Northwest Local Schools Renewal Levy

At its Jan. 24 meeting, the Northwest Local School District Board of Education voted to place a renewal levy on the May 3, 2011, ballot.

Key Points to Remember

1. This is Not a New Tax

- a. This is a renewal levy that will simply maintain the \$1.5 million that is currently being collected from a levy that was passed in 1992.
- **b.** This levy has been renewed every five years and the millage reduced every year since that time.

2. The Renewal Levy Maintains What We Have

- a. Passing this renewal levy will keep the Northwest Local Schools out of debt, according to the five year forecast.
- **b.** It would also allow the district to maintain its current operations and programs.
- **c.** State deficits and cuts are looming.

3. This is a Continuation of Your Plan. Your Vote.

- **a.** As part of the plan set forth by the Independent Financial Oversight Committee, this renewal levy would have to pass in order for the district to be financially solvent.
- **b.** This is simply a continuation of the plan that has already been put in place.

4. This Renewal Levy is for Operating Money

a. This renewal levy has nothing to do with school building construction

b. The up-and-coming construction and remodeling projects are being paid for with state matching funds.

An avid supporter of the school district, she was aware of the impact that the financial crisis has had on the library program. Dian puts it simply, "I like to read, and I wanted the kids to have additional books to read."

Having volunteered at Stinson Elementary's book fair, Dian was instrumental in starting the middle school's first Scholastic Book Fair in 2009, during which \$1,400 worth of books were sold. In 2010 the middle school nearly doubled the amount made previously, selling \$2,700 worth of books for a 50 percent profit in Scholastic books.

Larry Murgatroyd has served as President of the Northwest Athletic Charitable Committee (ACC) for the past three years, and he volunteers for the school district because he lives in the community and wants to give back. Athletic Director Gary Woods is extremely grateful for the work performed by the ACC and the leadership provided by Larry: "The ACC has been a tremendous asset to our financially strapped district. Their efforts have enabled us to eliminate our debt on the home and visitor's side bleachers at a cost of \$400,000 and dramatically reduce our debt on the all-weather track, which was a balance of about \$40,000 on a \$150,000 project. As president of the group, Larry's leadership and personal investment of time has been priceless."

Thin Client Computing and LED Lighting will Help Northwest Save Energy Thanks to H.B. 264

Computers can be an invaluable tool for school districts. However, the cost of owning, operating and repairing computers can be equally expensive. Based on the specific type of computing hardware and accessories as well as software updates and "fixes," energy and maintenance cannot be ignored. Finally, the cost of replacing individual computers for an entire district can be daunting and has not been done at Northwest Local for many years. In fact, most of our computers are older than our students.

A portion of our Energy Conservation Program will address reducing the utility and operating costs of computing through the implementation of a server based "Thin Client" computing system. This system will eliminate the

need for individual computers while at the same time maintaining the same fundamental computing experience from the user's perspective. The operating system is provided by a server, which is housed in the district. The district will be running Windows 7 Pro on all Thin Client terminals. The Thin Client terminals come equipped with a monitor, keyboard, mouse and a WYSE (Brand) Thin Client mounted on the back of the monitor. This program will not only reduce operational and repair costs, but will produce a reduction in electrical consumption for Northwest. The net cost to the district through savings will be zero dollars out of pocket for these upgrades.

Community Recycling – Help support the Northwest Athletic programs and recycle at the same time!

Two dumpsters have been placed in town for the collection of aluminum cans - one at the bus garage and one by the high school. PSC Metals

Another aspect of H.B. 264 is new LED lighting in the campus parking lots, beginning with the high school lot. Although the high school is only fouryears-old, new technologies have been developed in that time which will reduce energy consumption costs while providing more and safer lighting. The new lights will only draw 136 watts yet provide lighting that registers 1,000 watts. Other energy savings will be achieved through automatic lights switches and heating controls. The energy savings to the school district will be approximately \$1 million in 10 years. has donated pickup and drop-off services for the dumpsters. All we have to do is fill them with our aluminum cans!

School District Income Tax

The Northwest School District Income Tax that was approved by voters went into effect on January 1. In the October issue of the *Northwest News* we covered many general facts about the implementation of the tax. Since that time a few specific questions have been raised. Following are answers to the most frequently ask questions.

My employer says that withholding the tax is voluntary and doesn't want to withhold the tax from my paycheck. The Ohio Department of Taxation sent all employers an annual Withholding Update in December. The first sentence in the update states that Ohio law requires employers to canvass their employees, and if they live within the boundaries of a school district with an income tax they must withhold the tax from an employee's compensation. A copy of this employer notification can be viewed at the Northwest Web site. If you or

your employer would prefer to talk to someone at the Ohio Department of Taxation, call Bob Davidson at 614.466.3094.

My employer won't withhold the tax or I am selfemployed and I want to make estimated tax

payments. What do I do? To make estimated tax payments visit the Ohio Department of Taxation Web site, http://tax.ohio.gov/divisions/school_district_ income/index.stm, and select More School District Income Tax Forms. This link will provide you with the estimated tax vouchers necessary to make a tax payment. The form will require you to enter a school district code number, and the correct code number for Northwest Local is **7612**. Again, if you would prefer to talk to someone at the Department of Taxation, call Sylvester Monroe at 614.466.0090.
