Northwest Local Schools has been very fortunate to experience some significant successes and advances in recent years. This is quite different from what the district was going through about ten years ago. At this time ten years ago, Northwest was placed in fiscal caution by the Ohio Department of Education, was laying off teachers at an alarming rate, was not replacing resources such as textbooks and buses, was not staying current on some payments for services, and our athletic teams were without a conference to compete in and enjoy rivalries on the playing field.

After reaching out to the community through informal coffees and group gatherings, it was determined that Northwest Local should attempt to get community approval of a five year 1% Earned Income Tax. The tax would only be paid by citizens of the district with earned income and would not tax things like interest, social security, and other retirement income. Our community stepped up and passed the request and also passed a renewal in 2014. Each time the issue was on the ballot, the term has been for a period of five years.

The time has come for Northwest Local to ask our community for your support again by renewing the Earned Income Tax. The Earned Income Tax has benefited the students of Northwest and our community greatly. The students have achieved tremendous academic successes through scholarships that are awarded to our graduates, our results on the state testing standards are consistently one of the best throughout Stark County, and through technology our students are learning in new and innovative ways. Students at Northwest now compete in an athletic conference that provides them with the opportunity to regularly play teams from neighboring areas and against other athletes they may have played against or maybe even with for several years. We have also taken great strides and continue to evaluate and improve safety measures for students. We have not brought back all the teaching positions that were laid off, but we have added a few classes for students who may need help in specific

The community has had the opportunity to use Northwest Local facilities for a number of activities: the community theater holds performances, the Stark County YMCA operates numerous programs for our children in the schools, a local church got its start in the high school, an alumni football game is held in our stadium, and the Rotary uses our campus as a base for their fund-raiser "The Mother of all Races."

As you can see, we are very fortunate that we have the Earned Income Tax. We have been very mindful of the trust you have shown by passing the issue previously and also the expectations you have for us to use that money responsibly, efficiently, and wisely. MHJ Foundation Grant Awarded for **Literacy Training**

Northwest Local has received a Martha Holden Jennings Foundation grant that will be used to fund Language Essentials for Teaching of Reading and Spelling (LETRS) literacy professional development training for our K-3 staff. The LETRS professional development modules focus on evidence and researchbased reading and writing instructional strategies and techniques to meet the needs of all of our students. The assistance of the MHJ grant will enable the district to implement the LETR professional development training for our K-3 staff in a four-year timespan impacting the literacy instructional practices of our staff members resulting in a decreased number of students who are not on-track to meet the Third Grade Reading Guarantee. Research shows that students who are on-track in reading at the end of third grade are less likely to experience difficulty learning in all classroom subjects in higher grades. The strength of our K-3 literacy instruction directly impacts the success of our students throughout their school experience.

Literacy is a fundamental skill that opens the doors of learning and provides students with the ability to pursue knowledge and opportunities. A child's literacy skills develop and grow over time at varied intervals. Last year, the district implemented the Wilson Fundations Reading program in all of our kindergarten and 1st grade classrooms as part of our district literacy plan. The Fundations program lays the groundwork for life-long literacy using a systematic program that emphasizes critical foundational reading skills including: phonemic awareness, phonics/word study, high-frequency word study, vocabulary development, comprehension strategies, handwriting and spelling. This year, the Fundations program will be implemented in all of our 2nd grade classrooms as well. Teachers will continue to provide home support pack materials that will explain the concepts the students are currently learning and the activities that should be practiced at home to reinforce classroom instruction.

School Climate Grant

Northwest Local received a two-year School Climate Grant from the Ohio Department of Education. The grant funding will be used to develop a Positive Behavior Interventions and Support (PBIS) framework for Northwest Primary and Stinson Elementary. PBIS is a broad range of systematic and individualized strategies for promoting learning outcomes while preventing behavior problems. All K-5 staff members will be training in PBIS strategies and Ohio's social and emotional learning standards. By training our staff members in PBIS and socialemotional learning strategies, they will be better able to equip our students with the stills and knowledge necessary to problem solve, to think critically, and to develop resiliency, perseverance, and teamwork skills.

Each building will develop three to five clearly stated building-wide expectations and positive redirections that focus on early intervention that will reduce or prevent problematic behaviors. Research has shown that educators who embed social-emotional learning as they help students participate more fully in academic activities enhance the learning situations and increate student motivation to learn. The established routines create relationships and provide rules and expectations focused on early intervention; this, in turn, reduces or prevents problematic behaviors.

Child Find

In an effort to serve young people with disabilities, Northwest Local is continually in the process of locating and evaluating children from 3 to 21 years of age who are suspected as having a disability. Disabilities may include developmental delays, health impairments, autism, and traumatic brain injury. Individuals may contact the building Principals or Director of Special Services about children suspected as having a disability that may qualify for special education services. Information is available about special education policies and procedures in each building by contacting the building Principal. Northwest has a child identification process that includes the location, identification and evaluation of a child suspected of having a disability within and outside of district buildings. The Department of Special Services coordinates the child identification process. The Northwest evaluation staff uses a variety of community resources and systematic activities in order to identify children requiring special services. Included in this effort is consultation with appropriate representatives of private school students attending private schools located within the boundaries of the Northwest Local district to carry out this process. Northwest ensures that this process for students attending private or religious schools located in the Northwest is comparable to activities undertaken for students with disabilities served in the public school setting. If you have questions about the process, please call Victoria Hessey, Director of Special Services, at 330-854-2292.

Meal Charging Policy

The goal of Northwest Local Schools Food and Nutrition Department is first and foremost to provide healthy and nutritious meals to our students so they can better function and learn at school. However, there are guidelines in place that must be followed. Therefore, there will be no charging of meals by students or adults. Our policy will be as follows at any level:

- Students will not be allowed to charge meals or ala carte items.
- Students must have cash or a sufficient account balance to make a purchase.
- Students whose account balance falls below \$5.00 will be verbally notified of their balance at the cash register.
- This same procedure applies to adults.

To make this a success for both home and school, we offer an online program "PayForIt" that allows parents/guardians to deposit money into their child's account (at www.northwest.sparcc.org then click on Parent Tab then Payforit). This can be managed from home, allowing the parent to check lunch balances. You will need students 10 digit student ID number to access. This can be obtained through the school secretaries or the cafeteria. You may also send cash or check with your child/student to school to be deposited into their lunch account. One check can be written for all students in the same family. Please list in the memo section the student's name and how much money you would like on each of the accounts.

The school lunch program also offers free and reduced lunches for those families whose income meet the criteria. Parents/ Guardians may apply online at www.northwest.sparcc. org under the Parent Tab. Forms must be completed each school year to qualify. Only one application per family unit needs to be completed. Forms also can be completed any time during the school year should a situation arise that you may need assistance. We also have applications available at the school offices. It is best to fill these forms out as soon as possible to make it a smooth transition for your child/student.

We realize there are, of course, those times when students or parents/guardians forget lunch money. In this case, we will allow High School/Middle school students a onetime charge that day with the intention the charge must be paid the following day. Stinson and NW Primary will have a three-day charge limit with the intention the charge must be paid after these days. If this continues past the day/days your child/student will be given an alternative lunch, such as a turkey deli sandwich plus a milk for two days following. If the charge is still not paid, the student will not be able to purchase a breakfast/lunch from the cafeteria. The parent/guardian will be contacted by the school to discuss what options are available in order for the student to be able to obtain a lunch in the cafeteria. If a satisfactory resolution is not obtained after these efforts, a letter will be sent home along with this charge policy and we will also send an application for the Free and Reduced lunch program.

Thank you for participating in the Northwest lunch program.

PUBLIC RELEASE

Northwest Local School District announced its 2019-2020 program year policy for free and reduced-price meals or free milk for students unable to pay the full price of meals or milk served under the National School Lunch and School Breakfast, After School Care Snack or Special Milk Program. Each school office and the central office has a copy of the policy, which may be reviewed by any interested party.

The Federal Income Eligibility Guidelines will be used for determining eligibility. Children from families whose annual income is at or below the Federal Guidelines are eligible for free and reduced-price meals or free milk if the school participates in the Special Milk Program.

Application forms are being distributed to all homes in a letter to parents or guardians. To apply for free and reduced-price benefits, households should fill out the application and return it to the school. Additional copies are available at the principal's office in each school. A complete application is required. Households which currently receive Special Nutrition Assistance Program Benefits (SNAP, formally known as food stamps) or Ohio Works First (OWF) funds for a child must provide the child's name, the SNAP or OWF case number and signature of an adult household member on the application. Households which do not receive SNAP or OWF funds

New Advisory Period at High School

How does one get every student in a high school more connected and involved in the school culture and spirit? You get them on an extracurricular or cocurricular team or you get them to join a club. Beginning this 2019-2020 school year, students will get to experience a new Advisory Period in the middle of the day that will allow every student an additional way to be a part of the school. An adjustment will occur in the high school schedule whereby, what was formerly Intervention from 7:30-8:00 a.m., will now be a period dedicated to clubs and activities from 10:50-11:19 a.m. A particular club will meet once a week on a designated day, and every student at the high school will be given the opportunity to join one or more clubs. Clubs will include, but definitely not be limited to, Speech and Debate, Model UN, Mock Trial, Girls Who Code, Photography Club, WOW, Stress Less Club, Poetry Out Loud, Writer's Workshop, Book Club, Art Club, Science Club, InDesign--the list goes on and on. This initiative will allow Northwest to bring clubs to the school that otherwise would never be possible. The opportunities are endless. More information and details will be given to students when they return to school. We are excited about the many opportunities that await our students!

New Cell Phone Policy

Beginning this 2019-2020 school year, Northwest High School will be a cell phone-free zone from the moment the students enter the building up to the 2:20 p.m. final bell.

Students who interact with their cell phones in class perform worse on tests--often a full letter grade or more. In fact, simply having phones within reach, whether they are used or not, can cause academic performance to decline. Recent research also indicates that the mere presence of the cell phone, even when it is silenced and stored out of sight, might affect students' ability to focus.

More importantly, research has shown that, as screen time increases, so does the likelihood of a student identifying themselves as being unhappy. And as the hours compound, so does the level of unhappiness. We also know that students spend an enormous amount of time on their devices from 12 midnight to 4 in the morning. This causes sleep deprivation which adds to the stress and anxiety levels of students. The bottom line is to reduce the amount of screen time for our young people.

We at Northwest High School are committed to greatly reducing screen time while the students are in our care. Because of this commitment to our students and their social and emotional well-being, cell phone use is no longer permitted during the school day. In case of an emergency, parents can call the school office phone (330-854-2205) and we will convey the message (just like the old days). We would ask that parents not attempt to call or text a child's cellphone during

A Message from Officer Muntean

As we head into a new school year, I'd like to discuss the Canal Fulton Police Department's role in our schools. Officer Stetka and I will be assigned as our school resource officers for the 2019-2020 school year. We have both completed our state certification as certified Ohio School Resource Officers, and we have hundreds of hours of related training and certifications.

The goal of our SRO program includes providing safe learning environments in our schools, providing valuable resources to school staff members, fostering positive relationships with youth, developing strategies to resolve problems affecting youth, and protecting all students in order for them to be the best that they can be.

The three main roles of school resource officers are educator/guest lecturer, informal counselor/mentor, and law enforcement officers. The way each of these roles is carried out has the potential to keep youth out of involvement with the juvenile justice system. For example, when SROs instruct, they are helping youth develop important life skills that can result in healthier decisions. The counselor/mentor role is a way that SROs can help recognize students who may be facing a range of challenging issues in their lives, such as substance abuse, witnessing trauma at home or in the neighborhood, and/or mental health issues. Last, the law enforcement problem-solver role is yet another way the officer can divert students from involvement with the justice system.

In addition, we are tasked with all juvenile investigations, school bus passing complaints, and student truancy issues, among a multitude of other things.

We are on campus every school day, and are also available to assist parents who may be experiencing difficulties with their children. Let's all work together to develop this generation of children to their fullest potentials!

must provide the names of all household members, the last four digits of the Social Security Number of the adult signing the application or state "none" if the adult does not have a Social Security Number, the amount and source of income received by each household member, (state the monthly income) and the signature of an adult household member. If any of this information is missing, the school cannot process the application.

FREE HEALTH CARE

Families with children eligible for school meals may be eligible for FREE health care coverage through Medicaid and/or Ohio's Healthy Start & Healthy Families programs. These programs include coverage for doctor visits, immunizations, physicals, prescriptions, dental, vision, mental health, substance abuse and more. Please call 1-800-324-8680 for more information or to request an application. Information can also be found on the web at http://jfs.ohio.gov/ohp/consumers/familychild. stm. Anyone who has an Ohio Medicaid card is already receiving these services.

The information provided on the application is confidential and will be used only for the purpose of determining eligibility and may be verified at any time during the school year by school or other program official. To discourage the possibility of misrepresentation, the application forms contain a statement above the space for signature certifying that all information furnished is true and correct. Applications are being made in connection with the receipt of federal funds. Schools or other officials may check the information on the application at any time during the school year. Deliberate

misrepresentation of information may subject the applicant to prosecution under applicable state and federal

Foster children are categorically eligible for free meal benefits regardless of the household's income. If a family has foster children living with them and wishes to apply for such meals or milk for them, contact the school for more information

Under the provision of the policy, Dan Levengood, Treasurer, will review applications and determine eligibility. If a parent or guardian disagrees with the decision on the application or the result of verification, the decision may be discussed with the determining official on an informal basis. If a formal appeal is desired, the household has the right to a fair hearing. A fair hearing can be requested either orally or in writing: Dennis Lambes, Interim Superintendent, 2309 Locust St. S, Canal Fulton, Ohio 44614, 330.854.2291. The policy contains an outline of the hearing procedure.

Households may apply for benefits any time during the school year. If a household is not currently eligible and if the household size increases or income decreases because of unemployment or other reasons, the family should contact the school to file a new application. Such changes may make the children of the family eligible for free or reduced-price benefits if the family income falls at or below the levels shown above.

In accordance with Federal civil rights law and U.S. Department of Agriculture (USDA) civil rights

regulations and policies, the USDA, its Agencies, offices, and employees, and institutions participating in or administering USDA programs are prohibited from discriminating based on race, color, national origin, sex, disability, age, or reprisal or retaliation for prior civil rights activity in any program or activity conducted or funded by USDA.
