Interestingly, a great deal of the monies is "pass through" money but they still have to show it as revenue. The IU has come a long way in presenting what Mrs. Sperry termed as "an interesting budget" and reiterated that their board has never seen a complete one much like this before.

Mr. Joseph clarified what the amounts were for and indicated that the school improvements amount is based on the 14/15 fiscal weighted average, calculated by the Pennsylvania
