WHEREAS, in the judgment of the Board of School Directors of the Conneaut School District it has been determined, as a result of the study of the proposed budget presented to said Board at a meeting on March 7, 2015, held in the gymnasium of the Alice Schafer Annex, and tentatively adopted by the Board of School Directors on May 13, 2015, said school district must enact minimum salaries of its professional and supervisory employees and the mandated increases on salaries and further, in order to pay for various other expenses and obligations of the school district for the said school year;

NOW, THEREFORE, BE IT RESOLVED, AND IT IS HEREBY RESOLVED, that the Conneaut School District hereby enact a real estate tax on all taxable real property situated within the geographical limits of the Conneaut School District, said tax to be based upon the assessed valuation of such properties by the chief assessor Crawford County, Pennsylvania; and that the Conneaut School District hereby fixes a real estate tax millage for the school year 2015/2016 at 50.55 mills in order that salaries of its professional and supervisory employees and mandated increases on salaries, debts and obligations for capital improvements as well as all other various expenses and obligations of the school district. Said rate of taxation for the school year 2015/2016 as expressed in dollars and cents is \$50.55 on each \$100.00 of assessed valuation of taxable property.

WHEREAS, the Board of School Directors of the Conneaut School District desires to enact a Per Capita Tax for the school year 2015-2016 in conformity with Section 679 of the Public School Code of 1949, 24 P.S. 6-679;

WHEREAS, the enactment of said Per Capita Tax is necessary for the proper operation of the school district and for meeting the anticipated expenditures of the school district for the year 2015;

Conneaut School District June 16, 2015 Special Board Meeting and Additional Work Session Minutes NOW, THEREFORE, BE IT RESOLVED, AND IT IS HEREBY RESOLVED, by the Board of School Directors of the Conneaut School District that pursuant to the authority contained in the Public School Code of 1949, Section 679, thereof, 24 P.S. 6-679, a Per Capita

Section 1. An annual per capita tax, at the rate hereinafter established, is hereby levied, enacted and imposed upon each resident or inhabitant, being eighteen (18) years of age or older, and residing in the geographic area encompassed and covered by the Conneaut School District.

Section 2. The rate or amount of said per capita tax, hereby levied, enacted and imposed, shall be \$5.00 on each resident and inhabitant being (18) years of age or older, and residing in the Conneaut School District.

Section 3. The amount to be received from the collection of the tax herein imposed, levied and enacted, shall be used for general revenue purposes of the School District.

Section 4. The names of the residents and inhabitants taxable under the provisions of this resolution shall be furnished to the School District by the local assessors and/or the chief assessor of Crawford County, Pennsylvania, as the case may be, and in accordance with the applicable provisions of the laws and statutes of the Commonwealth of Pennsylvania relating thereto.

Section 5. In accordance with Section 680 of the Public School Code of 1949, as amended, every resident or inhabitant of the Conneaut School District, upon attaining eighteen (18) years of age and every inhabitant of said School District, shall within twelve (12) months of the happening thereof, notify the proper local assessor of the municipality wherein said individual resides or the chief assessor of Crawford County, Pennsylvania, of the fact that said individual has become of age or has become a resident or inhabitant. Any person failing, within said period of time, to notify the proper assessor or the chief assessor of Crawford County, Pennsylvania, shall, in addition to the tax levied herein, be liable to the Conneaut School District in a penal sum equal to such tax.

Section 6. The tax herein imposed, levied and enacted shall be collected in the same manner as other school taxes are collected under the applicable and pertinent provisions of the laws and statutes of the Commonwealth of Pennsylvania.

Section 7. All taxpayers subject to the payment of taxes under this resolution shall be entitled to a discount of three (3%) percent from the amount of such tax upon making payment of the whole amount thereof within two (2) months after the date of the tax notice. All taxpayers who shall fail to make payment of the tax herein imposed for four (4) months after the date of the tax notice, shall be charged a penalty of ten (10%) percent, which penalty shall be added to the taxes by the tax collector and be collected by him.

Section 8. The resolution is adopted pursuant to the Public School Code of 1949, Act of March 10, 1949, P.L. 30, and all of the provisions of such Act relating to the imposition,

Section 9. All applicable statutes and laws of the Commonwealth of Pennsylvania, relating to the assessment of subjects of taxation and the collection of taxes enacted by a public school district are hereby incorporated in this resolution by reference thereto excepting so far as this resolution conflicts therewith.

Section 10. If any section, clause or sentence or part of this resolution is for any reason found to be unconstitutional, illegal or invalid or in conflict with any provision of the Public School Code under which this resolution is adopted, such unconstitutionality, illegality, invalidity or conflict shall not affect or impair any of the remaining provisions, sentences, clauses or sections or parts of this resolution. It is hereby declared as the intent of the Conneaut School District that this resolution would have been adopted had such unconstitutional, illegal, invalid or conflicting sentence, clause, section or part thereto not been included herein.

# **Work Session Opened**

Mrs. Sperry opened the Additional Work Session with the following Discussion Items —

### NSBA Discussion -

Each participating Board member presented a brief overview of their experiences while attending the National School Board Association Conference in Nashville, TN.

Mr. Don Ellis, Jr. -

Mr. Ellis touched on the seminars he attended which included; 10 Best Practices to Avoid Liability; Limited Bullying; Systematic Approach to Safe Environment; Ensuring Students to Aspire Collaborating with Business Industries; Fun with Nepotism; Pitfalls with Employees Related; Establishing Partnerships with Industries; K-12 Education Workforce; Career and Technical Education; Early Learning Investments, Increasing Graduation Rates; and How School Boards and Leaders can Transform School Climate and Outcomes for Practice Standards and Strategies. He also heard from the Department of Ohio School Board Association, a speaker from Yahoo Tech.

Mr. Schaef asked if after attending the conference, there was anything the MR. Ellis felt the District needed to work on. Mr. Ellis feels the district should make sure secondary teachers are communicating with their elementary counterparts and working all the way through to the final goal of graduation. It is important to have it in line by third grade including a reduction of costs in special education and less remediation. This also involves an investment the district can make in early childhood, fewer IEP's if we can get the chance to start them off early in pre-k and Kindergarten.

Mr. Schaef suggested that we take some of these and explore at our next additional work session.

Short discussion regarding charters falling under municipalities; Mr. Joseph concluded it did not apply to the Commonwealth of Pennsylvania.

Choose to share two external visits she made while in Nashville, Tennessee. She first toured the Pearl-Cohn Entertainment Magnet School, which comprises of 159 schools, with 90 free and reduced lunches, 140 languages consistently in large with Kurdish people. They have 12 zoned high schools using block scheduling. Of the zoned areas there are 24 schools with 4 magnet schools and 8 specialty schools, a freshman academy which aids in a 70 percent increase to their graduation rate. In their zoned schools there is 70 percent mobility from zone to zone. Teachers are offered externships for 3 weeks a business in order to be familiar with hands on experiences.

At the Pearl-Cohn Entertainment Magnet School it provides every aspect of the entertainment industry from a recording studio to a TV station.

The Vanderbelt University she toured a video conferencing STEM lab which can provide long distance learning. She was able to see demonstrations on computers to med school students in the operating rooms using realistic dummies. An operator is behind a one way mirror providing the scenarios for the medical students in order to teach them how to react to different scenarios, which provides them with a real learning experience.

### Mrs. Cheryl Krachkowski-

Her video started off with the NSBA Conference motto "their future starts with you in Nashville". Mrs. Krachkowski wanted to accomplish specific goals, gain knowledge and information in leadership, see and hear what issues other boards are facing, develop fellowship with fellow board members and inspire change.

One of the sessions she attended was regarding Continuous Improvement from Board room to Classroom which three of our board goals apply towards student achievement and analyzing data monthly. One of her models provides this data review and the success for academics. She is not suggesting we move towards this but defiantly attention needs to be given to it if there is a streamlined effort to promote accountability.

She also attended "What's up at the Workplace Cooler: employee challenges to evaluation firing decision and employee bullying. This workshop went to great lengths in discussing monitoring excessively is considered bullying. She felt we should allow administration to do their work.

On a side note during the session, there was discussion of "what is free speech, is speech constitutionally protected?" This speaks as a citizen on matters of public concern and interest of the employee outweighs that of employer.

The next session she attended was "leading change in challenging times with leadership versus management: 4 c's: critical thinking, communication, collaboration and creativity.

Mrs. Krachkowski attended Data Savy vs. Data Dangerous: meaningful questions for deeper understanding; Data for decision making, which includes demographic data, climate data, achievement data and financial data. Some financial information we should ask ourselves did not stand out that we have not already asked ourselves.

Conneaut School District June 16, 2015 Special Board Meeting and Additional Work Session Minutes Another session was Enhancing Student Achievement by Building Engagement hope and well being. This was important to me as research shows if we increase engagement by only 1 percent then reading scores go up 6 percent and math by 8 percent.

She suggested a tool to use called the Student Gallup Poll which explores three areas. It is free to a district and ties in with one of the board goals to engage/involve the community.

Lastly, she found interesting a slide that discusses three types of employees; the engaged employee; non-engaged (too busy); and the actively disengaged (the nah sayer).

Her goals were accomplished, particularly fellowship. There are inspirations all around you, you just have to recognize it, change is good, just go first with 21 ways to inspire change. Mrs. Krachkowski thanked her fellow board and community to travel to Nashville.

### Mrs. Dot Luckock-

She thanked the district for the opportunity to go and reviewed a summary she had previously read at the April meeting. She found meeting others very beneficial and found that sometimes it makes you appreciate what you have. She found speakers to be very good and one of the biggest she found that struck her was Jane Pauley, a last minute speaker. Ms. Pauley stressed we must be able to teach the children we have not the ones we used to have or wished we had. She also found interesting a high prevalence of attendees using technology during the sessions and outside, adults buried in technology.

The sessions she attended included Digital learning; Research Based Policies and Practices to ensure Students are Prepared of Colleges and Careers; Rigorous Academics; Beyond the Sessions. She also enjoyed some regular sessions such as Pipelines Working for Employment Cooperative Agreement with Businesses; and Show Me the Money Session.

Mr. Schaef felt this has been a wonderful presentation of those attending and sharing the information. It helps us to think outside the box. As Mr. Ellis had said if the rest of us can come up with a couple ideas that tie into our goals and make schools better such as improve academic standards and if we could sit down in September with the new curriculum direct to incorporate some steps.

Mrs. Sperry reminded those that since the Board approved renewing the PSBA membership another year, the conference next April, 2016 is in Boston, MA.

### **Graduation Projects**

Mr. Maskrey and Mr. Sperry updated the Board on graduation projects. The state is ending this requirement for graduation after the end of the 2015/2016 school year. Therefore, this next year's seniors will be the last class required to complete the projects. In talking with the Board and the high school guidance counselors, over time, some take the project seriously and some do not. The higher level students already do the assignments in the projects but it is the lower learning students that the Board was dissatisfied with. He feels students were under pressure with testing's but if we can remove some of the obstacles it would benefit them. It is Mr. Maskrey's desire to remove the graduation projects after the 15/16 school year.

Conneaut School District June 16, 2015 Special Board Meeting and Additional Work Session Minutes Some items in Career Cruising have been inconsistent as when you enter in the program your likes and dislikes the results that the program indicates a student would be good at are odd. But now, we have a three year grant with WIN Learning and we plan on incorporating this program in conjunction with guidance and classes in order to develop a true career map for students to follow/guide them as they go through their high school years. It will help direct them with the classes they need to take in order to be prepared after high school graduation. We saw a number of students admit that they were not aware of certain classes they should have taken in order to be prepared for their next step. It was only in working on their graduation project that they realized the error.

The guidance counselors have a plan starting next year, which the middle school counselors have already started the process. Beginning with the upcoming 9<sup>th</sup> graders they will come to the high school with their portfolios the start of the year. Students will still be required to job shadow and do institution/college visits.

Mr. Hines provided some background on what the guidance counselors have been working on and indicated that since the end of last year and through this fall have meet with representatives from the state on a K-12 career path plan. It will be implemented officially the start of the 16/17 school year.

It was noted Mr. Burnham left the meeting at 8:59 PM due to farm responsibilities.

Mr. Sperry provided a video regarding the changes employers and educators are seeing in the job market called "1, 2, 7". Which identified fewer college degreed openings versus a higher number of specialized trade jobs have been left unfilled and are of high need.

Mr. Maskrey noted a concern he had this past year is that some students were leaving their regular classes to work on their projects but with using WIN Learning this next school year it should help diminish the problems. Mrs. Sperry agreed, she too felt the WIN program will help fix some of the problems the District has had in the past. Mr. Sperry added that the program is even more sophisticated now than a few years ago.

Mr. Boyce commented that he recently worked with a career counselor who conducted a career assessment. He went through a series of tests and what came back are what he had the aptitude in. His response to the counselor was "where were you 30 years ago", and feels the WIN career assessment would be huge for our students.
