He would like to say a few words of arming teachers is absurd. Teachers spend years earning degrees, getting certifications and then start to work and spend additional years working on Masters, additional certifications, we need all that. But now we are asking them to take on additional responsibility to become killers. There is no other word for it, if we train our teachers to us a hand gun, then we are expecting them to use it. Say an armed intruder comes in we expect them to pull their weapon otherwise what is the point. There is no point, but there can be other situations, what about a student that becomes upset, irrational in the classroom and threatens people. The student gets ahold of a knife and a teacher is expected to shoot the student. Is that what we want in our schools. Just this evening I was watching KDKA and in California a school armed resource

officer who also a police officer, accidentally discharged his handgun in a classroom. The bullet went into the ceiling and metal fragments flew and hit one student in the neck/throat.
