15.i. Committee Reports - Policy Committee/Added - Information Update from Solicitor on LERTA Guidelines

Minutes

Mr. Sperry noted the Policy Committee met before this board meeting and are wrapping up the 800 policies. Starting on the 900 and that will complete the first full cycle of reviewing the policies.

Mr. Joseph provided an informational update on the LERTA inquiry. He started off noting there is no relation to the Mr. Joseph who is asking for the tax abatement. LERTA as a tax abatement methodology there are a number of statutes and is a local economical tax assessment act which provides for improvements to deteriorated businesses

or industrial properties. So LERTA in relation to Mr. Josephs proposal which is residential. LERTA as that statute is written. But there is a companion statute that does govern residential properties and the statute is for improvements of deteriorated real property or Areas Tax Exemption Act. It does the same as LERTA but is residential. It is important for the Boards consideration that the statute authorizes tax issued for borough and district to exempt improvements to certain areas.

In order to do that the process is for local taxing districts, including this district, the statute does define deteriorated property in a deteriorating neighborhood or dwelling as defined by health agencies as an unfit for human habitation or subject of order requiring to be condemned. The dwelling unit means, house, rooms, etc for occupancy improvements defined as deteriorated neighborhoods are designated by taxing authority by ordinance resolution and exempt or ability exempt from property tax the assessed value of improvements and statute gives a number of different options of scheduling that. It requires the local taxing districts to define or identify fix and hold on public hearing for purposes of determining the properties. Of course two or more local taxing districts can act together. Different options for exemption schedules such as four ten year exemptions and it decreases each year. Another is a five year at 20 percent each year; a third option is available and a full 100 percent exemption for ten years. No exemption could extend 10 years. So for our boards purposes if inclined to consider an exemption for improvement for resident you would have to make hearing and determine if the area is deteriorating with the definition give.

Mrs. Luckock noted Sadsbury Township has determined the property not a deteriorating neighborhood and she has not heard from our board members to move this request forward.

Mrs. Miller, given all that, we don't' have to take it further.

Mrs. Luckock thanked the District Solicitor for the clarification

Mr. Hall felt that the fact Mr. Joseph the requestor is calling a corn field dilapidated he takes offense to that, farmers are proud of their field... there is no residence there.

Attorney Joseph mentioned the property is currently one tax parcel and the tax received by the District is \$1,000. His proposal subdivides and is doing that anyway and when he does that, it in itself results in increased tax revenue to the District.

Amaeda Potts, addressed the Board, she has three daughters, one of them spoke on masks and now it is my turn. Today the masks were struck down, I am sure all of you heard how we feel and how it should be our choice. No the question to Mr. Sperry can we expect an all call that the mask mandate no longer is in affect and it is parents' choice. This is all over in January, a month and a half earlier won't hurt. Nurses say the masks don't work. Mr. Sperry started us without masks this school year then the health secretary called it. Please make the call tonight, and do what others are doing, our community deserves that. show us how to be a leader.

Mrs. Luckock noted tonight George Joseph, our district solicitor will be giving us the latest update on the legal community. The decision of the court appealed by the acting secretary of health through the supreme court issued an email to all the school districts that appeal the constituents an automatic stay and mask stay in until the Act. He expects an expedited process for the appeal to the Supreme courts as of 6 pm that is the update. It has been an appeal filed and acts as an automatic stay.

John Jay, the Vice President of the Conneaut Mobile Property Association, lives at the bottom of the hill from the location Todd Joseph is asking for a tax abatement. He has been living here since 1957. The property Todd Joseph is asking for a tax abatement on used to be a driving range and has been closed for years. It is now a corn field as the District Solicitor said. He doesn't' believe it is a dilapidated state of repair and believes an email was sent out to the Board. When he appeared before for the tax abatement he, Todd Joseph, indicated if granted that this board would reap the benefits of \$3 million dollars. The problem with that is he doesn't even have a plan yet, not

approved by the township planning for anything. He is denied tax and the township has reciprocal with the county as they both are together. So the request if he comes forward, that this board do the same, deny.

Megan Wenko, a student at CASH, most of you have heard Mr. Todd Joseph bought the Park and planned to make properties for housing. She doesn't support his request, his plan was denied and at the last board meeting he argued on the reason, requested to earn money to develop on underdeveloped where she lives. That plan is to buy and build, his plan put to rest without building so close is not a good thing due to water runoff. It won't be good for ecosystem. We already lost the park, she loved the park and wanted it to stay forever. He has prevented that; it is a shame if he prevents more disappointment. So since Sadsbury rejected it will he try to buy another property. In an article he wrote he states it helped benefit without the township and she asks that to be redacted. Thank you for making the decision to reject his plan.

Brooke Luethold, the first food for thought she sat through the last meeting and liked the idea of the board slides pamphlet. It was brought to my attention some kids cannot play sports, they cannot afford it. Is there something that helps these kids out. Let's make it known for those that want to play but can't afford it. Also for your wifi kids she talked to 15 families who took that last year, it is included in the rescue plan. Also, you put \$2,000 aside for kids having trouble at home paying bills, have yet to vote on that and wondering why as people need that. The girls up here made a point of masks, she understands the laws but Governor Wolf put a hold on til January because he is a dictator. She doesn't understand his way of appealing it, he said he did it because we are in a different place than in September. Mr. Sperry calls every Friday with updates, we have been pretty low so why we can't say enough is enough.

Tasha Williams and Julia Mattocks, came here because of an incident that happened to my son, he is autistic but throughout the district he is bounced around from school to school and it seems you don't have the proper education. George Joseph interrupted and noted we are in a public session; do you want to do this in pubic or we can take it to the executive session. As a district we have to protect the privacy rights of your son. She answered she wants everyone to hear her story. She noted she has talked to Mr. Sperry, has watched the video, the incident and please note my son is nonverbal autistic and that is not ok. He went from Conneaut Valley Elementary Learning Support room, kicked out and broke his nose due to 9 people holding him down. Was transferred to LS and no one knows what is going on. He now has a missing tooth so now has to have oral surgery. Mr. Parks did not touch him, the video showed otherwise and all my son did is standup on the bus and jumped around. He slide over Mr. Parks and you can hear his tooth pop on the video. I also have pictures. I asked for an IEP and took physical restraint out of it, still no IEP meeting, he has a stay at home order now. she is tired of truancy threats and not happy with the bullying in this district. He has been stabbed with pencils, so who will stand up for these kids. Special needs children, it is a dang shame you should have proper training and you won't send him to Sarah Reed or pay the tuition. Ms. Dressel shot it down due to busing. She has talked to lawyers and PDE and it is the Districts duty, you are to provide him school work weekly. He has had his school work done for a week and they are saying he cannot do his work, he does have his moments, but it is not my job to teach my child. By law it is the parents' choice, not all of you that is why you have IEP meetings and I am to approve them. My child has been assaulted and I want him out of there. Mrs. Luckock thanked her, noted it sounds like a conflicted situation that the Board is not familiar with. Mrs. Williams claimed it was addressed last Thursday with everyone, everyone in the board she thought it was this board. Mrs. Luckock noted the board is not educators and but this matter will be addressed in our executive session after this meeting.

Robert Bazylak approached the podium. He lives below the area Todd Joseph is asking for the tax abatement. The area is not a dilapidated area but a corn field. He asked the board to decline Todd Joseph's request just as Sadsbury Township has.

Kimberly Motzing approached the podium. she spoke about middle school sports and students who are unable to participate due to costs. Mrs. Luckock directed her to the athletic director and/or sports coach as there are sponsors available.
