- COVID-19 extensive mitigation efforts on-going at all campuses

### Lower Campus

- Hurricane Ida repairs will be completed by the Archdiocese
  - No negative impact to student instruction expected
  - Roof repairs may be required
- All state and city inspections are up to date and the organization is in compliance on all safety and security issues.

### Johnson Campus

- Hurricane IDA
  - NOLA-PS filed an insurance claim for Hurricane Ida damages
    - NOLA-PS managed the initial remediation efforts
    - Pending repairs:
      - ceiling tiles - Lycée has replaced 80% and are awaiting reimbursement
      - floor tiles
      - exterior fence
- Chiller/HVAC

- NOLA-PS has provided close-out documentation for the project
- Lycée is in the process of seeking a 3rd party evaluation of the project
- Street Repairs
  - The City of New Orleans is in the process of street renovations near the campus and an update will be provided at the March 2022 Facilities Committee Meeting.
- Custodial Vendor
  - As a result of Hurricane IDA and ongoing custodial staffing shortages a 3rd party vendor has been providing cleaning services.

#### McNair Campus

- Hurricane IDA

      - ceiling tiles - Lycée has replaced 90% and are awaiting reimbursement
      - exterior fence

- All safety, health, and security inspections are current and the organization is in compliance.

#### Operations

##### COVID-19

- COVID-19 policy changes aligned with NOLA-PS - indoor masking, cleaning in schools(high touch surfaces), revised isolation guidance, and quarantine guidance.

##### Transportation

- RFP process underway.
- It is expected that there will be a significant increase in student transportation services, which is a nationwide trend.

#### Meal Services

- An RFP is not needed for the FY22-23 school year. Two options available
  - Option 1: Healthy School Food Collaborative (HSFC) has recommended renewing the contract with Genuine Foods LLC for an additional year as opposed to going out for bids.

- Option 2: New Orleans Public Schools Child Nutrition Department has been contacted and we'll be meeting to discuss options for the FY22-23 school years. NOLA-PS's program does not require going out for bids and would eliminate the need for services provided by HSFC.

Athletics Department

- New Athletics Director Hired - Nick Tringali
- Both basketball and archery seasons are coming to a close.
- Plans were implemented to establish the tennis, flag football, soccer, and girls volleyball teams. Currently, coaches and facilities are being secured for these teams.

- This spring, the athletics department is looking into a co-ed softball/kickball team for 9th-11th graders to better engage our high school students.
- An eSports club was established at the McNair campus with goals to become a full team for the next academic year. eSports is a non-sanctioned but recognized LHSAA sport and a rapidly growing global competitive activity.
- LFNO applied to join the LHSAA and has a scheduled school site visit from a compliance officer in March 2022 (date TBA). The LHSAA executive committee will review and vote on LFNO’s application for membership on April 6th or 7th, 2022.
