## Fee Subsidy/Scholarship Request Information

Thanks to the generous monetary donations of District 31 families, the Education Foundation and the Parent Teacher Club, District 31 is able to offer fee subsidies/scholarships for the athletic program, school musical and band programs at Field Middle School. The subsidy/scholarship program is designed to provide financial assistance to District 31 families in financial need, in order to enable their students to participate in Field Middle School extracurricular programs.

Based on the availability of funds, District 31 will attempt to provide financial assistance to those students who meet the eligibility requirements. District 31 reserves the right to approve full or partial assistance or deny an applicant's request. Please note the following:

1. The *Financial Assistance Application* must be completely filled out. For athletic program requests, a current physical, *Sports Authorization Form* and *Extracurricular Participation Agreement* must be on file. For the musical program, only an *Extracurricular Participation Agreement* must be on file,
2. The application will be reviewed and processed by Erin Murphy, principal of Field Middle School.
3. Upon submission of a *Financial Assistance Application*, families will be notified within 5 school days or less of their scholarship status.
4. Financial assistance is based on need and availability of funds and will be awarded on a first come-first serve basis during the current school year.
5. All submitted information is confidential and is not a matter of public record.
6. All information provided on the application must be true and accurate. Financial assistance awarded on the basis of false information supplied by the applicant will be revoked.
