The Regular Meeting of the Regional School District 14 Board of Education was held on Monday, November 21, 2011, in the Nonnewaug High School Library, 5 Minortown Road, Woodbury, Connecticut.

Mr. Davenport delivered an informative and engaging 60 minute presentation of the NHS Agriscience Program, featuring reports from students, testimonials from graduates and parents, and recommendations for the future of the program. Students competing nationally in areas of Food Science, Nursery/Landscaping, Floriculture, Farm Business Management, Forestry, Job Interviewing, Meat Judging, Mechanics, Livestock Evaluation, Poultry Evaluation, and Communications told of their performances and placement in competition. Parent/Community advisors Ed Bartolotta, Alice Wilkerson and Dan Caron spoke of the value of the program; and graduates Colin Sieracki, Tom DeMarco, Erica Foster and Mike Schneider explained the benefits they gained from having attended the program. In his closing, Mr. Davenport thanked the board and community for continued support of the program and suggested perhaps monthly reports from students and/or parents, during privilege of the floor, to enhance the level of communication and awareness between the school and community.

Julie Haggard, Woodbury, supports a remedy to the bus stop issue on Quanapaug Trail; appreciates the administration's help and hopes to resolve this issue in a timely fashion – hopefully within the next few weeks. She wondered what the process involves, and was told by Mr. Bauer that Mr. Reese will interface with the Transportation Committee and the bus company to resolve the issue. He appreciates Ms. Haggard's patience. Ms. Van Aken was surprised to hear of a policy stating 45 minutes as a maximum bus ride. She urged resolving this issue soon and is baffled as to why it is taking so long.

Jeanne Hawley, Woodbury, asked for resolution in the matter of accommodating Girl Scouts who wish to ride a bus from BES to MES for troop meetings. She suggested that only 35 students ride the dedicated bus to the 3 licensed day care providers and so perhaps that bus could be utilized for the scouts. She asked when a decision is anticipated, since the year is almost half over. Mr. Goeler replied that he would speak with Mr. Reese in the morning.

Х. **Committee Reports**

For Policy, Mr. Chapman reported having met to review new school climate legislation. His committee will meet again tomorrow and will look to make a recommendation to the board to adopt a new policy prior to the 1/2012 deadline. The policy wording will be very prescriptive/specific. Bus policy and bylaws related to meeting agendas will be addressed next, he said.

Traffic flow at NHS was discussed, as was emergency preparedness, the bus stop at Quanapaug Trail, and the Girl Scout transportation issue.

Mr. Suslavich reported for the Finance Committee. He told of a 2009-10, 2010-11 funding error affecting the towns which will be resolved. His committee reviewed budget transfers and heard that the district budget is almost 99% spent or encumbered for this year.

Mr. Bauer *motioned to accept the NHS Energy Efficiency Proposal dated 11/14/2011.* Seconded by Mr. Suslavich, the **motion carried 7-0.**
