TITLE Gender Inclusion

I. PURPOSE

The purpose of this policy is to establish the District's expectations and accountability measures for ensuring safety, support, inclusion and equity in the context of gender for all students, families and staff.

II. GENERAL STATEMENT OF POLICY

St. Louis Park Public Schools is committed to ensuring that the District's learning communities honor and respect the gender identity and gender expression of all students, families and staff.

III. DEFINITIONS

- A. "Gender" refers to the socially constructed roles, activities, behaviors and attributes that a given society attaches to femininity or masculinity.
- B. "Gender Expression" means the manner in which persons represent or express gender to others, often through behavior, clothing, hairstyles, activities, voice, or mannerisms.
- C. "Gender Identity" means a person's deeply held sense or knowledge of one's own gender, regardless of the sex assigned at birth.
- D. "Gender Non-Binary" is an umbrella term for people who transcend commonly held concepts of gender through their own expressions and identities. Other terms for this include gender diverse, gender expansive, gender creative, gender nonconforming or genderqueer. Some non-binary people also identify as transgender.
- E. "Transgender" is an umbrella term describing persons whose gender identity or expression is different from that traditionally associated with their sex at birth.

The School Board understands that terminology used to describe gender, gender

expression and gender identity can differ or vary between cultures and every effort should be made to use terms that honor the individual's identity.

IV. NAMES AND PRONOUNS

St. Louis Park Public Schools will respect the gender identity and gender expression of all students, families and staff. Additionally, all district staff will identify and address students, families and other district staff by their preferred names and pronouns

V. ACADEMIC PROGRAMMING

Within academic programming, the separation of students and/or curricular materials based upon gender is prohibited unless it serves as a legitimate pedagogical tool and aligns with the purpose of this policy.

VI. CO-CURRICULAR AND EXTRA-CURRICULAR ACTIVITIES

All students will be provided the opportunity to participate in co-curricular and extracurricular activities in a manner consistent with their gender identity, including but not limited to intramural and interscholastic athletics, and in conformance with Minnesota State High School League rules and regulations, where applicable

VII. ACCESS TO FACILITIES

St. Louis Park Public Schools will provide all students, families and staff with access to facilities that align with their gender identity.

VIII. BULLYING, HARRASSMENT AND DISCRIMINATION

Bullying, harassment, and discrimination on the basis of gender identity or expression are prohibited. See also district policy 413 (Harassment and Violence), 514 (Bullying Prohibition), 522 (Title IX Nondiscrimination Policy, Grievance Procedure and Process), 526 (Hazing Prohibition), 528 (Student Parental, Family and Marital Status Nondiscrimination).

IX. PRIVACY

Pursuant to district policy 515 (Protection & Privacy of Pupil Records), district policy 406 (Public & Private Personnel Data), and state and federal privacy laws, the District will respect the safety and privacy of all students, families and staff.

X. APPLICATION OF ALL DISTRICT POLICIES

All St. Louis Park Public Schools policies apply to all students, families and staff, regardless of their gender identity or gender expression. This includes, but is not limited to, policies 102 Equal Education Opportunity, 406 Public & Private

Personnel Data, 413 Harassment and Violence, 423 Employee-Student Relationships, 425 Staff Development, 514 Bullying Prohibition, 515 Protection & Privacy of Pupil Records, 522 Student Sex Nondiscrimination, 526 Hazing Prohibition, 528 Student, Parental, Family & Marital Status Nondiscrimination and 610 Field Trips.

XI. INTERSECTIONALITY OF RACE & GENDER

St. Louis Park Public Schools recognizes the existence of intersectionality of race and gender identity and race and gender expression, and supports efforts to mitigate adverse effects on students', families' and staff's well-being, success and ability to participate fully in the school community.

XII. REPORTING

- A. Any person who believes there has been a violation of this policy shall report the alleged violation immediately to an appropriate school district official designated by this policy.
- B. The school district encourages the reporting party or complainant to use the report form available online or from the principal or building supervisor of each building or available in the school district office, but oral reports shall be considered complaints as well.
- C. The building principal, the principal's designee, or the building supervisor (hereinafter the "building report taker") is the person responsible for receiving reports of a violation of this policy at the building level. Any person may report a violation directly to a school district human rights officer or the superintendent. If the complaint involves the building report taker, the complaint shall be made or filed directly with the superintendent or the school district human rights officer by the reporting party or complainant.
- D. The building report taker shall ensure that this policy and its procedures, practices, consequences and sanctions are fairly and fully implemented and shall serve as the primary contact on policy and procedural matters. The building report taker or a third party designated by the school district shall be responsible for the investigation
- E. A teacher, school administrator, volunteer, contractor, or other school employee shall report situations, circumstances, or events that might be a violation of this policy.

- F. Reports of a violation of this policy are classified as private educational and/or personnel data and/or confidential investigative data and will not be disclosed except as permitted by law. The building report taker, in conjunction with the responsible authority, shall be responsible for keeping and regulating access to any report of a policy violation and the record of any resulting investigation.
- G. Submission of a good faith complaint or report of a policy violation or other prohibited conduct will not affect the complainant's or reporter's future employment, grades, or work assignments, or educational or work environment.
- H. The school district will respect the privacy of the complainant(s), the individual(s) against whom the complaint is filed, and the witnesses as much as possible, consistent with the school district's obligation to investigate, take appropriate action, and comply with any legal disclosure obligations.
- I. All students, families and staff are to be made aware of the reporting procedures annually.

XIII. ACCOUNTABILITY MEASURES

- A. The Board shall conduct its business in alignment with this policy.
- B. The Superintendent shall establish, in accordance with this policy, such plans and procedures as necessary and appropriate to accomplish its purpose and intent. Plans and procedures shall include clear accountability for actions and oversight, and shall include metrics for evaluation.
- C. Professional Development
The Superintendent will provide annual professional development to ensure that staff understands their responsibilities pursuant to this policy. Professional development must include:
 - 1. Review of this policy and its implementation at all school sites.
 - 2. Additional attention will be given to the intersectionality of race and gender inclusion.
 - 3. Attention should be paid to educating staff on reporting procedures.
- D. Review
The School Board will review this policy annually. Review should include voices of students, families and staff most impacted by this policy, with a particular focus on those who identify as transgender or gender diverse. Review

shall also include an update from the Superintendent which will identify plans and procedures developed and implemented pursuant to this policy, as well as professional development offered to staff.
