### ***Roseland Montessori School***

#### ***School Parent and Family Engagement Policy***

##### **A. ANNUAL TITLE I MEETING**

Roseland Montessori School will take the following actions to jointly develop with parents of participating children a school-parent compact that outlines how families, school, staff, and students will share the responsibility for improved student academic achievement and develop a partnership to help children achieve the state's high standard and how the plan is used, reviewed, and updated.

### **G. BUILD CAPACITY OF PARENTS**

Roseland Montessori School will build the parents' capacity for strong parental involvement to ensure effective involvement of parents and families and to support a partnership among the school and the community to improve student academic achievement through the following:

- Materials and training to help parents to work with their child to improve their child's achievement, such as literacy training and using technology (including education about the harms of copyright piracy), as appropriate, to foster parental involvement
