Attendance

Regular attendance and punctuality are essential for academic growth and development. Hinsdale Central High School expects that each student attends his or her classes every day. Since class participation affects class achievement, absences, whether excused or unexcused, may have a negative impact on learning and the grade earned in class. Section 26-2a of the Illinois School Code and Board Policy 7:70, considers VALID CAUSE for a student's absence to be considered excused.

Excused Absences

Students can be excused from a full day of school for the following reasons:

- ٠ Illness
- Observance of a religious holiday
- Death in the immediate family
- Family emergency
- Voting (see Board Policy 7:90, Release During School Hours
- Circumstances which cause reasonable concern to the parent/guardian for the students' mental, emotional, or physical health or safety
- Other situations beyond the control of the students as determined by the Board of Education
 - Hospitalization
 - Court dates
 - <u>College visits when Pre-Arranged Absence procedures are followed</u>

Pre-Arranged Absences

Pre-Arranged Absence forms may be obtained on the school website. The form must be filled out properly submitted to the Deans' Office two (2) days before the absence in order for it to be excused. Parents or guardians will need to contact the Attendance Office in order to verify the absence. If the form and documentation are not turned in for college visits, the absence will be considered unexcused and counted in determining excessive absences. Participation in a non-school related competitive activity or sport are not recommended when school is in session and will be considered unexcused and counted towards excessive absences if the form and documentation is not turned in. The form needs to be filled out for the following absences and documentation that supports the request for the absence:

- **College Visits**
- Participation in a non-school related competitive activity or sport

In order to comply with School Code, the school reserves the right to determine if an absence is excused. The school considers the following reasons as examples of absences without valid cause, thereby resulting in an unexcused absence.

Unexcused Absences

- Oversleeping
- Car trouble
- "Cutting" class
- Missing the bus
- Missing one class to study for another or make-up test and quizzes

- Babysitting
- Shopping

Make-up Work Due to an Unexcused Absence

Students marked UPC – Unexcused Parent Call

✓ If a student has an unexcused absence from class on a day when a test/quiz or assignment is due, the student must turn in the assignment the next school day or take the test/quiz the next school day. Teachers have the option to give an alternative assessment.

- Extending Prom Weekend
- Resting or preparing for special events
- Senior Ditch Day
- Vacations

<u>Tip Line</u>

The <u>Tip Line</u> is an anonymous reporting system that is available online or through the ParentLink app. Submitted tips are directed to the designated school administrator.

Administrators and/or school resource officer will follow-up on all tips and respond in an appropriate manner. Please provide as much information as possible so that every effort can be made to resolve the issue.

Weekly Updates

This school year D86 will be sending weekly updates regarding grades and attendance home via email. Any concerns regarding attendance, please stop by the Deans' Office.

Outside Deliveries/Lunch Drop Off

Hinsdale Central does not allow deliveries for food or other items from outside vendors. In order to keep our campus safe and secure, we ask that lunch drop off be limited for emergency purposes.

Assessments/Exams

Students that have 3 or assessments that fall on the same day may request to have an assessment moved.

Students that have 3 exams in one day during semester exam week may request to move an exam to study hall or make-up period.

Accommodations to move an exam due to vacation plans, work or other outside obligations may be declined.

Forms to move must be approved by the Deans Office prior to making arrangements to move an exam.

Pre-Arranged Absence Links

Students that will be going on a college visit or are invloved in athletics/activites outside of Hinsdale Central, should fill out a Pre-Arranged Absence Request Form in order for the absence to be excused. Link is located in the document about under excused absences and on the website in the Deans Office section.

- Students are required to wear a mask and their student issued ID card/ lanyard.
- Take all school emergency drills seriously knowing your options during an emergency and what to do will assist should a real emergency occur. The better prepared we are, the less likely we are to be injured or harmed.
- During school hours never allow a fellow student, parent, or stranger to gain access to the school by opening a locked door or propping a door open. There are procedures in place to check people in during school hours for everyone's protection. Compromising this process can be dangerous to all of us.
- When in the halls during class time YOU NEED A PASS. Security officers have been instructed to address students in the hallway without passes and return them to their class. This will be enforced regularly so be prepared and get a pass before leaving the classroom.
- IF YOU SEE SOMETHING, SAY SOMETHING a phrase you hear all the time but an important one. School safety is a priority and ultimately everyone plays a role in trying to make Central a safe place. If you ever witness or observe something suspicious or dangerous don't hesitate to bring that information forward to any staff member, school official, or via the tip line.

Bus Procedures

Students who are assigned to and utilizing the bus transportation provided by the district are required to wear a face covering, regardless of vaccination status, for the duration of the trip to and from school. Students who refuse to wear a mask on the bus may be denied boarding or asked to exit the vehicle. Drivers will also wear personal protective equipment while operating the vehicle. Students who forget a mask will be given a mask by the bus driver, that mask is expected to be worn while on the bus and in school.

Bullying/Harassment Reporting

We believe a student's right to feel safe in school is paramount and contributes significantly to his or her capacity for learning and social development. Currently, District 86 schools have a protocol for reporting bullying and dealing with offenders which largely calls on students to approach adults and describe the incident. However, it is our belief that bullying goes unreported because students, for a number of reasons, may not be comfortable reporting incidents, or reporting incidents to school personnel.

In our on-going effort to maintain a safe learning environment for all of our students, District 86 has reporting resources to report bullying/harassment. We encourage students/parents to utilize this resources to report any bullying/harassing behavior of which they have knowledge. When a message is retrieved by school personnel the incident will be investigated and responded to accordingly.

<u>Who can I go to for help?</u>

Students are assigned by Student Support Teams. Student Support Teams consist of student support coordinator, counselors, deans, social workers, school psychologists, and nurses meet weekly to assess student progress with regards to academic issues, social/emotional challenges and behavioral concerns. Each team brainstorms strategies and interventions to better assist students and promote success during high school.

Parking

Access to Parking Off-Campus - Students that do not have a parking permit
