All bidders must provide familial disclosure in compliance with MCL 380.1267 and attach this information to the bid proposal. The bid proposal will be accompanied by a sworn and notarized statement disclosing any familial relationship that exists between the owner or any employee of the bidder and any member of the Troy School Board or the Troy School Districts Superintendent. Also, a sworn and notarized Affidavit of compliance for the Iran Economic Sanctions Act certifying the vendor does and will comply with Public Act 517 of 2012 shall accompany all proposals. Both forms will be enclosed in the specification's booklet that shall be used for this purpose. The District will not accept a bid proposal that does not include these sworn and notarized disclosure statement.

# **PROPOSAL**

- 1. The Troy School District will receive firm, sealed bids for replacement wireless network controllers, in accordance with the specifications below.
- 2. Proposals will be submitted only on the forms provided, will be enclosed in a sealed envelope marked with the name of the bidder, the title of the work "Bid 9947 Wireless Network Controllers" and must be delivered to Troy School District, Services Building/Technology Department, 4420 Livernois Road, Troy, MI 48098, ATTN: Beth Soggs, Technology Director, no later than 10:00 a.m., Tuesday, May 24, 2022, at which time all bids will be publicly opened and read aloud immediately thereafter. Bid proposals received after this time will not be considered or accepted. Oral, telephone, fax, or electronic mail bids are invalid and will not receive consideration. Submit one original and two copies.
- 3. Proposals will be made in conformity with all the conditions set forth in the specifications.
- 4. All questions regarding the bid specified, or the bid terms and conditions will be accepted in writing ONLY and subsequently answered through an addendum to all interested parties. - 5. References in the specifications to any article, product, material, fixture, form, or type of construction, etc., by proprietary name, manufacturer, make or catalog number will be interpreted as establishing a standard quality of design and will not be construed as limiting proposals.
- 6. Bid bond or certified check, for an amount not less than five (5%) percent of the amount of the bid, must accompany each bid. Failure to submit proper bid security shall constitute rejection of bid.
- 7. A completed Familial Disclosure and an Iran Economic Sanctions form must be included with each proposal submitted or the proposal will not be accepted, <u>please note these forms must be notarized</u>.
- 8. The Troy Board of Education reserves the right to accept or reject any or all proposals either in whole or in part; to waive any irregularities and/or informalities; and in general, to make awards or cancel this proposal, if deemed to be in the best interests of the owner.

#### **GENERAL**

- 1. Troy School District is soliciting proposals to replace existing wireless network controllers
- 2. Proposed solution must be capable of supporting Cisco access point models AIR-AP2802I-B-K9, AIR-AP1542I-B-K9 and AIR-AP1562D-B-K9
- 3. Proposed solution must support minimum throughput of 40Gbps
- 4. Proposed solution must support 32,000 clients and 2000 access points
- 5. Proposed solution must integrate with Cisco Prime Infrastructure and Cisco ISE
- 6. Proposed solution shall provide high availability and replicate changes between devices automatically

- 7. All hardware proposed shall have a warranty period of not less than five (5) years.
- 8. All hardware proposed much include all AP (Access Point) licenses necessary for a period of not less than five (5) years.
- 9. All hardware proposed must have redundant power supplies
- 10. Current controller utilizes 8 connections to a core router using cisco part SFP-H10GB-CU3M. The final state of connections should be 8 connections to core router. Any optics\cables needed for migration is the responsibility of the bidder.

#### SCOPE

The project will consist of the following phases:

- 1. Discovery Assess current wireless infrastructure and policy engine design and develop implementation plan document
- 2. Planning Solution should include complete redesign and configuration of secure and guest wireless authentication mechanisms. Any modifications to topology and policies will be planned and documented in an implementation plan.
- 3. Installation Racking, connecting, and modifying any interlink connectivity as needed. Any changes required to topology or policy engine shall be included in the bidder's cost. The solution must be integrated into the current management platform which is Prime Infrastructure version 3.8. <u>Bidder is</u> responsible for updating Prime to the latest recommended release.
- 4. Testing Testing shall be in a scaled approach starting with a small group of clients before cutting over any site. The current controller should remain running while the testing phase is in process.
- 5. Migration Migrate from existing wireless controller to new. If any downtime is required for migration, an agreed upon maintenance window between the bidder and owner must be established.
- 6. Support Bidder shall provide next day cut over support with dedicated resource
- 7. Documentation Implementation plan shall be finalized becoming As-Built for the project with customer having final sign off.
- 8. Training Bidder must provide an overview of new product and functionality along knowledge transfer to owner.

#### **WARRANTY**

All material and equipment will be guaranteed to be free from defects in both workmanship and materials for no less than five years from the date of receipt/installation. If the manufacturer's warranty exceeds this minimum requirement, the manufacturer warranty will prevail. Any item(s) found to be defective will be replaced or repaired within seven working days at Vendor(s) expense.

#### **FIRM PRICING**

Unit pricing will prevail when computing total quantity on bids. No price allowance or extra consideration on behalf of the bidder will subsequently be allowed by reason of error or oversight on the part of the bidder. The successful bidder(s) will hold bid prices firm for all purchase orders placed for a period of approximately one full year.

# **TAXES**

Troy School District is not automatically exempt from State of Michigan Sales and Use Taxes. The district must pay these taxes when materials are to be incorporated into reality. Materials that are permanently attached, built-in, incorporated or otherwise made part of the structure all applicable taxes shall be paid by the vendor. Troy School District shall not be responsible for any taxes that are imposed on the vendor. Furthermore, the vendor understands that it cannot claim exemption from taxes by virtue of any exemption that is provided to Troy School District.

#### CONTRACT AWARD

The contract will be awarded in the form of purchase orders emailed or mailed to the Vendor(s) selected. It is the intent to award the bid on June 21, 2022, at the regular monthly meeting of the Board of Education.

# WITHDRAWAL OF BIDS

Any bidder may withdraw their bid at any time prior to the scheduled time for receipt of bids. No proposal may be withdrawn until 45 days after bid opening.

All shipments will be F.O.B. delivered, Troy School District, Michigan, to the Services Building located at 4420 Livernois Road, Troy, MI 48098.
