# AMENDMENT TO LEASE AGREEMENT LITTLEJOHN CAMPUS

This AMENDMENT to the Lease Agreement is made by and between San Juan Unified School District ("District") and California Montessori Project Charter Schools ("CMP" or "Charter School"), and is dated as of this 23rd day of June, 2015.

#### WITNESSETH:

WHEREAS, the District and Tenant have previously executed the lease agreement dated June 28, 2011 (the "Lease") pursuant to the terms of which Tenant has leased from the District the Littlejohn Elementary School Site, located at 6838 Kermit Lane, Fair Oaks, California 95628 ("School Site") containing the building thereon, contiguous school grounds and non-exclusive use of the school parking lot, restrooms, playground and playing fields thereon, as shown in Exhibit A of the Lease amendment.

**WHEREAS,** the District and Tenant have agreed to make certain modifications to the Lease, which modifications will supersede and replace the language as referenced:

NOW THEREFORE, in consideration of the mutual promises contained herein and for other good and valuable consideration, the receipt and adequacy of which is hereby acknowledge, effective July 1, 2015, the parties agree as follows:

Section 4.a. is amended to strike the first paragraph and inserting in lieu thereof the following:

a. <u>Facilities Costs</u>: CMP shall pay a pro rata share of the District's facilities costs as provided in 5 C.C.R. Section 11969.7 (referred to herein as "pro rata share charge"). The pro rata charges for the 2015-2016 school year are provided as Exhibit A of the 2015-2016 lease amendment, attached hereto and included herein. The pro rata share amount shall be paid monthly. The obligation to begin paying the pro rata share charge shall begin on the date of possession, July 1, 2015, and shall end on June 30, 2016.

Except as modified by the terms of this Amendment, all other terms and conditions of the Lease shall remain in full force and effect.
