CMP has created a plan to serve students, with a focus on students experiencing learning loss and/or not engaging with the class. The plan has been discussed with Parents and Teachers at Campus Advisory Council meetings as well as Staff Meetings.

A description of how students will be identified and the needs of students will be assessed.

Students will be identified based on the following: Students who show below grade level according to local diagnostics; Student demographic information (low-income, English learner, foster youth, homeless students, students with disabilities, students at risk of abuse); Disengaged students, per the Engagement Trackers; Teacher recommendation.

The academic needs of students will be assessed using the i-Ready diagnostic. The social-emotional needs of students will be assessed using the Engagement Tracker and Teacher input.

Parents and guardians of students will be informed of the opportunities through letters sent to the home and/or utilizing ParentSquare, a parent communication system. Communications regarding opportunities will be provided in the family's home language, as applicable.

The plan to provide supplemental instruction and support will be:

Reading support and intervention through Read Naturally Live, SIPPS, and Sunday.

Math support and intervention with groups of students with similar abilities to provide evidence-based instruction through the Kidz Math program.

Ongoing Montessori lessons and follow up activities delivered by credentialed Teachers.

CMP will offer Project Lead the Way during the summer intersession as an engaging, hands-on STEM program to enhance in-demand knowledge and skills

Elk Grove Unified School District plans to provide meal options to students through the federal Seamless Summer Option. CMP will notify families of how to access these families through ParentSquare.

The Club Montessori summer intersession will be open to students. CMP will continue to work with local agencies that provide financial support for families who need it.
