##### **Application:**

Completed applications must be submitted electronically through [www.losal.org](http://www.losal.org) by the deadline date noted on this job flyer. **NO PAPER APPLICATIONS WILL BE ACCEPTED!**

\* Be sure your application reflects all relevant experience, paid or volunteer. Attach a supplemental resume or other description of experience if it is not adequately described on your application. **Please attach copies of your California Special Driver Certificate, California Class A or B driver license with passenger endorsement, medical card (DL-51), Red Cross First Aid Card (if applicable), and H-6 printout (current – within 30 days) to your application.**

##### **Examination:**

Applications may be screened to select the most qualified candidates.

The examination will consist of:

- A - Written job knowledge test (30% of Total Score)
- B - Structured oral interview (70% of Total Score)
- C – Practical Bus Inspection and Bus Operation (Pass/Fail)

Some classifications require you to pass a physical examination and/or a practical examination. This examination is at the district's expense and the appointment is not assured until you have passed this examination. Applicants must attain a passing score of 70% on each part of the examination in order to be placed on the eligibility list. Should a large number of candidates pass the written exam, a higher passing score than 70% may be required to progress. **Candidates who pass the written and panel interview will be placed on an eligibility list valid for six (6) months.**
