

**OLDHAM COUNTY BOARD OF EDUCATION  
MEETING MINUTES  
September 28, 2020**

The Oldham County Board of Education met in regular session at the Arvin Center, on Monday, **September 28, 2020**, with the following members present: Kevin Woosley, Board Vice Chair, Larry Dodson, Board Member; Patrick Kehoe, Board Member; Suzanne Hundley, Board Member; and Greg Schultz, Superintendent and Secretary to the Board. Joyce Fletcher, Chairwoman was absent from the meeting. The meeting was held in person (less than 50 people and social distancing practices in place), recorded and live streamed for the public viewing.

**I. MEETING CALLED TO ORDER**

Vice-Chairperson Woosley called the meeting of the Oldham County Board of Education to order at 4:30 p.m.
