

**OLDHAM COUNTY BOARD OF EDUCATION
MEETING MINUTES
April 12, 2021**

SPECIAL CALLED BOARD MEETING

The Oldham County Board of Education met in a working session at the Arvin Education Center in La Grange, KY, on Monday, April 12, 2021, with the following members present: Joyce Fletcher, Board Chairperson; Kevin Woosley, Board Vice Chair, Larry Dodson, Board Member; Patrick Kehoe, Board Member; Suzanne Hundley, Board Member; and Greg Schultz, Superintendent and Secretary to the Board. Eric Davis, Director of Student Services was present for the presentation of the Superintendent Report: School Administrators were also present for the session.

I. MEETING CALLED TO ORDER

Chairperson Fletcher called the meeting of the Oldham County Board of Education to order at 4:30 p.m.

II. AGENDA APPROVAL

With no changes to the agenda, chairperson Fletcher, called for a motion and a second to approve. On a motion by Suzanne Hundley, seconded by Larry Dodson, and unanimously carried, the Board approved the April 12, 2021, special called board meeting agenda. (5-0).

III. SUPERINTENDENT REPORTS

1. Consider Report on Drug Use Statistics and Common Drugs in the state.
 - a) Report by OCPD on drug use – Eric Davis, Director of Student Services shared the yearly drug breakdown report for Oldham County Schools. Mr. Davis then introduced State Trooper Zachary Napier from KY State Police who shared additional information about the most common drugs used in the state and what to look for with students with the board and OC administrators.

Questions and discussion followed the reports with no further interruption. No action was taken.

IV. EXECUTIVE SESSION
