

**OLDHAM COUNTY BOARD OF EDUCATION  
MEETING MINUTES  
August 9, 2021**

**BOARD MEETING WORKING SESSION**

The Oldham County Board of Education met in a working session at the Arvin Education Center in La Grange, KY, on Monday, August 9, 2021, with the following members present: Joyce Fletcher, Board Chairperson; Larry Dodson, Board Member; Patrick Kehoe, Board Member; Suzanne Hundley, Board Member; and Jason Radford, Superintendent and Secretary to the Board.

**1. MEETING CALLED TO ORDER**

Chairperson Fletcher called the meeting of the Oldham County Board of Education to order at 4:36 p.m.

**2. AGENDA APPROVAL**

With no changes to the agenda, chairperson Fletcher, called for a motion and a second to approve. On a motion by Suzanne Hundley, seconded by Patrick Kehoe, and unanimously carried, the Board approved the August 9, 2021, special called board meeting agenda. (4-0).

**3. SUPERINTENDENT REPORT**

1. Dr. Dylan Smith presented a report on Math Resources for OCS FY22. Question and Discussion from the board members followed the report, no action was taken by the board.
2. Leslie McKinney presented a report on MAP Reading Learning Loss FY21. Question and Discussion from the board members followed the report, no action was taken by the board. Immediately following this report, the board took a five-minute recess.
3. Dr. Jason Radford presented a report to update the board on school opening plans. Matt Rhodes from the Oldham County Health Department was available for questions from the board. An in-depth question and discussion from the board members followed the report. Action was taken by the board on the opening plan for OC Schools.

**4. ACTION ITEM**

- A. On a motion by Larry Dodson, seconded by Patrick Kehoe, the board failed to approved the OCS Opening Plan as presented with a temporary mask mandate to be discontinued at the Superintendent's discretion. (2,2)
- B. On a motion by Suzanne Hundley, seconded by Larry Dodson, and carried by a vote of 3-1, the Board approved the OCS Reopening plan with a mask mandate for all students and staff, which shall be reviewed at least once every 3 weeks by the Board.
- C. On a motion by Patrick Kehoe, seconded by Larry Dodson, the board failed to pass a requirement that all students and staff wear KN95 or N95 facemasks by a vote of 2-2

**5. ADJOURN**

With no further business to discuss, Chairperson Fletcher, called for a motion and a second to adjourn. On a motion by Larry Dodson, seconded by Suzanne Hundley, and unanimously carried, the Board adjourned the August 9, 2021, meeting at 7:31p.m. (4-0).
