

**OLDHAM COUNTY BOARD OF EDUCATION
MEETING MINUTES
January 10, 2022**

BOARD WORK SESSION MEETING

The Oldham County Board of Education met in a working session at the Arvin Education Center in La Grange, KY, on Monday, **January 10, 2022**, with the following members present: Joyce Fletcher, Board Chairperson; Larry Dodson, Board Vice Chair, Patrick Kehoe, Board Member; Suzanne Hundley, Board Member; Andrea Neikirk, Board Member and Jason Radford, Superintendent and Secretary to the Board.

1. MEETING CALLED TO ORDER

Chairperson Fletcher called the meeting of the Oldham County Board of Education to order at 4:35 p.m.

2. AGENDA APPROVAL

Chairperson Fletcher asked if there were any additions or changes to the agenda. Superintendent Radford said that there were two changes to the agenda, 1) move the OVEC presentation to the first presentation and 2) the addition of an Action Item B. Chairperson Fletcher, called for a motion and a second to approve the agenda with the changes. On a motion by Suzanne Hundley, seconded by Larry Dodson, and unanimously carried, the Board approved the January 10, 2022, work session board meeting agenda. (5-0).

3. SUPERINTENDENT REPORT

1. Rich Graviss and Dr. Stefanie Wooten-Burnett from U of L presented a report on the OVEC teacher residency plan. Question and Discussion from the board members followed the report, the report was taken under advisement and no action was taken by the board.
2. Leslie McKinney presented an update on Learning Loss to the board. Question and Discussion from the board members followed the report, the report was taken under advisement and no action was taken by the board.
3. Brent Bohannon presented a report to explain procedures on change orders for facilities. Question and Discussion from the board members followed the report. The report was taken under advisement and no action was taken by the board.
4. Assistant Superintendent Brent Deaves presented an update report on the COVID Return to School Plan and Update on quarantine and insolation procedures. Question and Discussion from the board members followed the report. The report was taken under advisement.

4. ACTION

- A. Approve the proposed COVID New Guidelines for Quarantine & Isolation.
Due to new guidance released on Jan 10, 2022 @ 4:30pm from KY Dept of Health, the board voted on the reduction of quarantine/isolation time of 10 days to 5 days only. Additional guidance and recommendation will be presented at the regular January 24, 2022 meeting once the new guidance is reviewed by committee.

On a motion by Suzanne Hundley, seconded by Andrea Neikirk, the Board approved the recommendation as discussed above. (5,0)

- B. Approve the recommendation to reinstate universal masking for OC Schools for 2 weeks beginning January 11, 2022, based on the high number of positive cases of students and staff and to protect in person learning.


