

**OLDHAM COUNTY BOARD OF EDUCATION  
MEETING MINUTES  
August 23, 2021**

The Oldham County Board of Education met in regular session at the Arvin Center, on Monday, August 23, 2021, with the following members present: Joyce Fletcher, Board Chairperson; Larry Dodson, Board Member; Patrick Kehoe, Board Member; Suzanne Hundley, Board Member; and Jason Radford, Superintendent and Secretary to the Board.

**1. MEETING CALLED TO ORDER**

Chairperson Fletcher called the meeting of the Oldham County Board of Education to order at 4:31 p.m.


**15. ADJOURN**
