ROBERT EVANS, EdD is a psychologist, author, and school consultant. He has worked with more than 1,700 schools, many of them ISACS members, on a wide range of issues, including board governance challenges. His interests are in leadership, helping schools manage change, improving adult relationships within schools, and crisis intervention. He is the author of many articles and three books, including *Seven Secrets of the Savvy School Leader: A Guide to Surviving and Thriving and The Human Side of School Change*. His newest book, *Hopes and Fears: Working with Today's Independent School Parents*, co-written with Michael Thompson, was published by the National Association of Independent Schools (NAIS).



LYNN WENDELL has worked as a consultant at more than 90 independent schools and non-profits. She served as a trustee at three independent schools and as board chair at San Francisco University High School (CA). In addition, she has served on non-profit boards, board committees, and advisory councils.



MARC FRANKEL, PhD is a senior consultant and partner in Triangle Associates, a consultancy specializing in higher, independent, and international education. He facilitates governance workshops, leadership development programs, and strategic planning and coaches independent school leaders. He has developed evaluation methodologies for boards and senior school leaders and co-founded the School Leadership Institute for NAIS. Frankel is the author of articles and white papers on governance and leadership issues. Frankel is a member of the board at the Wildwood School (CA).



ABIGAIL DeLESSIO is a senior consultant and partner at Triangle Associates. DeLessio partners with independent and international schools to provide strategic direction, focus, and insight, ensuring the identification and implementation of sustainable, strategic goals. She has led two school boards, including chairing the board of managers at Hong Kong International School (HKIS), one of the premier independent schools in Asia.



TIM FISH is the chief innovation officer at NAIS and a member of the Strategy Lab team, where he develops partnerships with member schools to co-create tools and frameworks that build capacity for designing and implementing demand-side innovation. He has deep roots in independent schools and a long history at McDonogh School (MD) where he served as the school's associate headmaster. In addition, Fish was the founding president and CEO of the FolioCollaborative, a nonprofit of more than 175 schools worldwide, focused on building a flexible faculty/staff development process, and is the co-author of *Leadership and Technology at Independent Schools*. He has served on six non-profit boards and currently serves on the board of Viewpoint School (CA).



DONNA OREM was named president of NAIS in November 2016 after serving as interim president since November 2015. Before becoming NAIS president, Orem served as the NAIS chief operating officer for 11 years. She joined NAIS as the vice president for educational leadership, later becoming the vice president for strategic initiatives and research. Prior to joining NAIS, she worked at the Council for Advancement and Support of Education (CASE), and she also served as associate director for The American Association of University Women. Orem is the co-author of the *NAIS Trustee Handbook, 10th edition*, and the author of numerous books and articles.



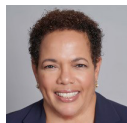

Before Stanley, Bhat was the head of middle school at St. Anne's Episcopal School (CO). He also worked as a department chair, dean of students, helped lead diversity work, and been actively involved in admissions in his different school communities from New Jersey to Boston to Colorado.



MEGAN MANN is legal counsel and a vice-president at NAIS. In her role, Mann supports the organization's legal and risk management needs, engages in advocacy efforts on behalf of NAIS schools, and provides legal education and support to member schools. Prior to joining NAIS, Mann was an employment and independent school attorney, acting as general counsel to independent schools across the country. She is a trustee for St. Michael's Episcopal School (VA) and One Schoolhouse.



LUCINDA LEE KATZ, PhD is a board governance consultant and executive coach. In 2018, she concluded a 14-year tenure as the head of school of Marin Country Day School (CA). Prior to MCDS, she worked with Mayor Daley in Chicago as the chief education officer and served as head of school and principal at The University of Chicago Laboratory Schools (IL) from 1986 to 2002. Katz served on the NAIS Editorial Board, was vice chair of NAIS, past president for the California Association of Independent Schools (CAIS), board chair for ISACS, and also served on three private school boards in CA. She has been a keynote and panelist speaker and made guest appearances on Oprah.



IRVENIA WATERS, MBA is an executive coach, team performance coach, and consultant. She brings to her work nearly three decades of experience in management consulting, strategy planning and execution, leadership development, and group facilitation. She has worked with dozens of independent schools and nonprofits and been a leader on independent school and nonprofit boards.



TERRY MOORE has been with ISM since 2002. He recently completed a three-year assignment at St. Mary's School (CA) where he served as the head of finance, operations, and advancement. During that assignment, he continued to consult for ISM. He has served more than 200 schools onsite since 2002, with many school leaders returning for additional advice year after year. He also acts as a senior writer for ISM's publications, including *Ideas & Perspectives*; created the ISM FAST@ program (ISM's cutting-edge financial aid tool), speaks at various conferences, including NBOA, NYSAIS, CAIS, FISBO, and AISNE, and leads ISM workshops and webinars.



ANNE-MARIE BALZANO, EdD is Mission and Data's senior governance strategist, where she designs learning opportunities for heads of school and boards and leads Mission and Data's Board Chair Support Program. A former teacher, head of school, associate professor, and most recently, director of leadership and governance at the NAIS, she possesses a unique and multi-leveled perspective of the educational landscape and the demands of supporting leadership and governance development. She facilitates board retreats and educates trustees on effective governance practices and trends, supports resilience in heads of school, and builds a positive board culture.
