- Ostatus Flag Comment: Yellow status is due to material shipment delays that are occurring
- Building "A": Overhead work continues to progress for the 1st and 2nd floor classrooms; 1st floor electrical rough-in is 85% complete; 2nd floor Overhead rough-in is 50% complete; Overhead inspection is scheduled for June 20th with the Final OSF inspection scheduled for July 29th
- Building "B1": Front Office/Lecture room overhead work is in progress; OSF overhead inspection is scheduled for July 6th; OSF Final is scheduled for August 3rd
- Building "D": IT speakers scheduled for install during the summer
- Building "G1" Main Gym HVAC is scheduled to begin once new units arrive; Painting and acoustical panels are scheduled to be completed prior to August 8th; Fire protection materials are onsite; Lighting fixtures are scheduled to arrive in June
- Building "G2" Addition: OSF overhead inspection passed; Roll up doors are scheduled to arrive in July; Roof is 95% complete; Remaining roof scope is scheduled for completion after the metal panels are installed at entry way; Panels are scheduled to arrive in June; Demo is scheduled to begin in June in preparation for the new locker rooms

- Yellow status is due to material shipment delays that are occurring with electrical switchgear
- Area "A" Gym: Slab is complete; CMU work is ongoing; Structural steel is scheduled to begin after completion of area B; Electrical rough-in and Masonry continue to progress; Completion is scheduled to occur in September
- Area "B" Small Classroom Wing: First floor beams are set; Decking is scheduled to start early June; Electrical rough-in continues to make progress
- Area "C" Large Classroom Wing: Decking is complete; 2nd floor slab scheduled for placement the week of June 6th; Stairs are scheduled to arrive in July; Art classrooms and connector walkway construction are scheduled to begin in October
- Area "D" Front Office and Media Center: Slab is Complete; Masonry work has begun
- Area "E" Cafeteria/Kitchen and Mechanical Yard: Kitchen underground rough-in is complete; Electrical and Mechanical room underground rough-in is complete
- Site utilities: Stormwater drainage is 50% complete; Site sewer is 15% complete; Lift station is ongoing; Lift station pump is scheduled to arrive in early July; Site utility water is 10% complete
- Electrical switchgear is scheduled to ship on April 13th, 2023

Financial Update



- All budgeted dollars for the projects equal the dollars approved by the referendum.
- The 4-30-22 appropriation amounts per project did not change from the initial budget at 2-28-20
- However individual budgets have been adjusted supported by the referendum contingency.
- The dollars spent and encumbered did not exceed the budgeted project total.
- The dollars spent per project did not exceed the estimated project percent completed.
- Material and Construction Cost continues to challenge cost control and schedule

Budget Summary 4/30/22

Beginning Budget \$344,610,000 Encumbered &Paid \$247,537,102

Remaining Budget \$ 97,072,898

Program Contingency as of 4/30/22 \$ 8,445,388

- There were no Project level transfers to Program Contingency in May
- Program Contingency used in May totaled \$5,182,390
- Program Contingency Budget as of 5/31/22: **\$3,262,998**



Program Reset will assist with determination of the adequacy of remaining contingency
