





- Building "D": IT speakers scheduled for install during the summer; IT infrastructure is complete in this area
- Building "A": 2 rooms remain to be demolished; Overhead work continues to progress in the 1st and 2nd floor classrooms; 1st floor electrical rough-in is 50% complete; 2nd floor Overhead rough-in has begun; Delivery issues with Fireproof materials were encountered; Fireproof subcontractor has found a workaround solution; Overhead inspection is scheduled for June 20th with Final OSF inspection scheduled for July 29th
- Building "H": Remaining HVAC is scheduled for installation during the summer; Replacement of coiling door is scheduled to be installed this summer; MBK continues to evaluate additional options for shade structure for area adjacent to cafeteria
- Building "G2" Addition: Roll up doors are scheduled to arrive in July; Overhead rough-in is 95% complete; Overhead inspection is scheduled for May 18th; Glazing is 90% complete; Roof is 95% complete; Remaining roof scope is scheduled for completion after the metal panels are installed at entry way; Exterior masonry is complete
- Building "B1": Front Office/Lecture room Demolition is currently ongoing and is 50% complete; Turnover is scheduled to occur after work is complete in areas A1 and A2

 - BB Concessions: Masonry is complete; Translucent panels order has been placed; Shipment is scheduled to occur the week of June 13th; Overhead is 90% complete; Roof is 25% complete
 - CC Field House: Interior masonry is complete; Exterior masonry is 10% complete; Structural Steel is complete
 - Site Utilities: Water line and site drain work is scheduled for completion on May 13th; Sanitary sewer is scheduled for completion on May 18th; Closeouts for BJWSA will begin after completion of the sanitary sewer; Electrical underground pipe install is 25% complete; Dominion Gas is arriving the week of May 15th; No update on electrical Dominion transformer; Contractor is proceeding with a temporary solution until the new transformer arrives; Workaround comprises the use of the old transformer
 - DD/EE Dugouts: Roofing is scheduled to be complete May 13th
 - FF (Additional Storage for Baseball and Softball): Remaining structure is scheduled for construction after building permit is received from the AHJ; Additional permit reviews from OSF are scheduled to complete in September; Building scheduled for completion in December 2022
 - Fields: Additional grading required around baseball and softball field; scheduled to happen before August football season; Track asphalt is scheduled to be installed the week of May 9th; Track surface is scheduled to begin the week of June 6th


