

# **Device Damage Loss Program**Application Form

## **District-Owned Student Device Option**

A computer (e.g. Mac, PC, Chromebook or iPad) is needed for students in grades 6-12 or those attending FLEX online school in order for them to do their schoolwork. All Beaverton School District (BSD) students in grades 6-12 and those who attend BSD FLEX online school have the opportunity to check out a district-owned Chromebook or iPad for use at school and at home.

#### Information about Wi-Fi Assistance

Adequate network connectivity at home is essential for the student to be able to complete their work while at home. If your family is in need of assistance with providing adequate Wi-Fi for your students, please see information about different options on the Beaverton School District website or ask your school's office staff.



## **Student Device Damage and Loss Protection Program**

BSD provides Device Damage and Loss Protection Coverage for a fee of \$20, or maximum fee of \$60 per family, per school year. This program protects families in situations where the student's device is damaged, lost or stolen. The \$20 fee to participate in the program is waived for CEP Designated Schools and families who qualify for the free or reduced meal benefits program and have completed the Permission to Share portion of the Meal Benefits Application.

Students using BSD district-owned devices may choose to decline the "Student Device Damage and Loss Protection Program" by selecting, "No Coverage". However, this is not recommended because the family is assuming full responsibility for any costs due to damage, loss or theft. These costs can be \$450 or more per incident, depending on the current prices from vendors.

Enrollment period for Device Protection Program coverage is no later than 60 days after the student begins school or has been issued a district-owned device. Fee payment is required prior to any damage or loss claims. More information about the Damage and Loss Protection Program, including what it covers, can be found on the BSD website.

Choose one of the following two options:

### ☐ Coverage - Damage Loss Protection Program

This limits family liability from accidental damage or loss of a student device.

- Choose this option if the student is checking out a district-owned device and requesting coverage.
- Make \$20 payment through the District Online Payment System or to the school bookkeeper within 60 days after student begins school or has been issued a district-owned device.
  - Note: For parents enrolling students who are new to the district, your online payment account will not be available for 24 hours.
  - o Students are not covered until the payment is made.
- Income Based Waiver: CEP school students and students qualified for free or reduced meal benefits should select this option. Fee will be waived automatically if the Permission to Share portion of the Meal Benefits Application has been completed, otherwise proof of application acceptance may be required by school.
- If you have payment questions, please see the school bookkeeper (high school) or office assistant (middle school).

#### □ No Coverage

- NOT RECOMMENDED FOR STUDENTS USING DISTRICT-OWNED DEVICES.
- Students using a district-owned device and selecting "No Coverage" signifies the
  family is assuming full responsibility for any costs due to damage, loss or theft,
  regardless of how it occurred fine charges could be \$450 or more depending
  on current vendor pricing.
