We are pleased to inform you that Clairton City School District will be implementing a new provision known as the Community Eligibility Provision (CEP) in the 2022-2023 school year. This program is available to schools and districts that are participating in the National School Lunch and School Breakfast Programs.

All enrolled students of Clairton City School District are eligible to receive a nutritional breakfast and lunch each school day at no charge to your household. No further action is required of you. Your child(ren) will be able to participate in these meal programs without paying a fee or submitting an application. The Richard B. Russell National School Lunch Act requires the information on this application. You do not have to give the information, but if you do not, we cannot approve your child for free or reduced price meals.
