**Student & Parent/Guardian Chromebook Agreement**

As a condition of using any Dunklin R-5 School District Chromebook assigned to me, I understand and hereby agree to the following:

**Student Responsibilities:**

- I understand that the Chromebook is and remains the property of the District, and that my use of the Chromebook is a privilege.
- I understand that my use of the Chromebook is for educational purposes only, and acknowledge that I have received and I agree to abide by the District Technology Acceptable Use Policy as well as all local, state, and federal laws.
- I agree to keep all accounts and/or passwords issued to me by the District secure. I will not share this information with any other students. This includes passwords for the Chromebook, email and/or network access and other school systems.
- I agree that I will never use this Chromebook to share personal information over the Internet, and, in addition, while using this Chromebook, if I am asked for personal information or harassed in any way I agree to report it immediately to my parents, teacher, or principal.
- I understand that my email (or any other communications) sent through the Chromebook should be appropriate, legitimate, and responsible communications, that these communications may be traceable to the District or me, and that I have no right to privacy concerning any communications made through this Chromebook or any information stored on the Chromebook.
- I agree that I will not install, download and/or otherwise utilize any software or data that is illegal, would violate copyright laws, or that would otherwise violate the District Technology Acceptable Use Policy. I also understand that when the Chromebook is returned to the District, the District may, in its sole discretion, reformat or otherwise erase any and all programs.
- I understand that all of my files, data and information stored on the Chromebook are not private, and that District personnel can review the Chromebook, and any files, data or information residing on the Chromebook, at any time.
- I understand that it is my responsibility to store and backup my data and that the District does not guarantee or warrant in any way the performance or quality of the Chromebook, and the District will not be liable for any direct or indirect, incidental or consequential damages (including lost or irrecoverable data or information) sustained or incurred in connection with the use, operation or inability to use the Chromebook.
- I will not attempt to repair or materially physically modify the Chromebook, nor will I attempt to clean it with anything other than a soft cloth, and I will report any problems with the Chromebook to District Office Staff.
- I will treat the Chromebook with care by, among other things, not leaving it outdoors or in a vehicle at extreme temperatures, by preventing physical abuse to the Chromebook (e.g. dropping it), and/or by not using it with food or drink in a way that may damage the Chromebook; I also agree to store and use the Chromebook in a manner designed to prevent theft or loss.
- I understand that if the Chromebook must be replaced due to damage, theft, or loss, any deductibles that apply will be required before another Chromebook will be issued to me.
- I understand that if the Chromebook is intentionally damaged, destroyed, stolen, or subject to intentional refusal to return to the District upon request, such conduct may result in criminal charges, whether in Juvenile or adult court, and will require restitution (criminal and/or civil).

My signature, as well as the signature of my parent/guardian, acknowledges receipt of the Chromebook and agreement to abide by the terms of the Chromebook Agreement as set out above. Parents/guardians will assume any financial responsibility for damages not covered by warranty.

Insurance Protection Enrollment Form

New for the 2017-2018 school year, in an effort to reduce costs for our families, Dunklin R-5 School District will be providing an Insurance Program. The insurance will cover the cost of accidental damage or theft of the district-provided Chromebook. This program is required to receive a Chromebook.

**Terms and Conditions**

You will be responsible for protecting your assigned device from loss or damage. If accidental loss or theft should occur, the Dunklin R-5 School District will waive your responsibility for the first financial loss. A deductible will be applied for multiple occurrences. An annual premium of \$25.00 per device will apply.

Payment via cash or check may be made in person in the high school office. At this time, payment made through your student's RevTrak account using Visa, MasterCard or checking/savings accounts is **NOT** available.

**Insurance Structure**

There is no deductible for the first covered claim for parents who have enrolled in the Insurance Program and paid the \$25.00 annual premium. Subsequent covered claims will be assessed as follows:

1st incident per covered device----- No Deductible

2nd incident per covered device-----\$50 Deductible

3rd incident per covered device-----\$100 Deductible

Students will not be issued a device while there is an unpaid deductible on their account.

**Losses Not Included in the Insurance Program**

Conditions not covered by the Insurance Program include:

- 1) Dishonest, fraudulent, malicious or criminal acts
- 2) Loss to software, data, documents, music, videos, recordings or other personal information placed on the device by the student

- 3) Loss caused by the failure to use all reasonable means to protect the device
- 4) Disappearance of the device without submitting a copy of a formal police report to school authorities
- 5) Any use not in accordance with District policies and procedures.

Dunklin R-5 School District will provide Chromebooks to students as tools for learning on and off campus. The use of the district-issued Chromebook is subject to all restrictions contained in District Policies and student behavior guidelines. Students and their parents must complete and sign this agreement and pay for the Insurance Program before a Chromebook will be issued.

Dunklin R-5 School District reserves the right to withdraw or limit use or possession of the Chromebook at its discretion.

**Student Agreement**

I understand that the District-provided Chromebook is the property of Dunklin R-5 School District. The Chromebook is provided for the purpose of accessing coursework and curriculum at school and at home. I understand that it is against District policy to use the Chromebook for dishonest, fraudulent, malicious or criminal acts. I understand that I am responsible for any loss to the device, its software or data. Documents, music, videos, recordings or other personal information placed on the device are accessible by District personnel.
