Notice is hereby given that the governing board ("Board") of the Pleasanton Unified School District ("District") will receive by electronic submission for the following project, **BLACKTOP REPAIRING AND RE-STRIPING**, Bid No. ~~2021-22-18~~ ("Project" or "Contract"). The Project consists of all labor, materials equipment and services necessary to **Repair and Re-stripe Blacktops**. Contract Documents are available as of 3 May, 2022, to be downloaded from the District's website, www.pleasantonusd.net using the link: https://www.pleasantonusd.net/apps/pages/index.jsp?uREC_ID=297080&type=d&pREC_ID=708966 .

The District will only receive bids submitted electronically. Bids will be received until **10 am, 16 May, 2022**, bids will be accepted only by **Google Form 2021-22.19**.

Any bid that is submitted after this time shall be nonresponsive and returned to the bidder. **Each bidder is solely responsible for timely submission of its bid; the District is not responsible for any technological issues in a bidder's ability to timely submit its bid or portion thereof.** Any claim by a bidder of error in its bid must be made in compliance with section 5100 et seq. of the Public Contract Code. Prior to publicly reading aloud bids at the video conference, the District reserves the right to verify the genuineness of any bid security.

To bid on this Project, the Bidder is required to be registered as a public works contractor with the Department of Industrial Relations and to possess one or more of the following State of California Contractor Licenses: **C12** . The Bidder's license(s) must remain active and in good standing throughout the term of the Contract.

A "voluntary" pre-bid conference and site visit will be held on ~~10 May, 2022~~ , at ~~10am~~ starting at Hearst Elementary School 5301 Case Ave, Pleasanton, CA 94566 in the back parking lot, ("Site Visit"). Arrangements could be made for those who cannot attend this specific date.

The successful Bidder shall be required to furnish a 100% Performance Bond and a 100% Payment Bond if it is awarded the contract for the Work. The successful Bidder may substitute securities for any monies withheld by the District to ensure performance under the Contract, in accordance with the provisions of section 22300 of the Public Contract Code.

The successful Bidder shall comply with all requirements of Division 2, Part 7, Chapter 1, of the Labor Code and Title 8 of the California Code of Regulations. For all work performed pursuant to this Contract, the Contractor and all subcontractors shall pay all workers not less than the general prevailing rate of per diem wages and for holiday and overtime work as determined by the Director of the Department of Industrial Relations, State of California, ("DIR") for the type of work performed and the locality in which the work is to be performed within the boundaries of the District, pursuant to sections 1770 et seq. of the California Labor Code. Prevailing wage rates are also available from the District or the DIR website at: <http://www.dir.ca.gov>. This Project is subject to labor compliance monitoring and enforcement by the DIR.
