## Issaquah School District Annual Wellness Policy Progress Report

The Issaquah School District's Nutrition Procedures Committee will compile and publish an annual report to share basic information about the wellness policy and report on the progress of the schools within the district in meeting wellness goals. This annual report will be published by every August and will include information from each school within the Issaquah School District.

The Issaquah School District's Nutrition Procedures Committee was established in the 2013-2014 school year to develop and implement comprehensive district-wide nutrition policies and procedures consistent with state and federal requirements for districts participating in the National School Lunch Program. The committee membership is comprised of the Director of Food Services, Kitchen Managers, Food Service Supervisor, School Nurse, DECA Advisor, CTE Specialist, Health Curriculum Specialist, Director of Purchasing, Director of Instructional Support, and parents.

The Nutrition Procedures Committee will meet to discuss and update the policy and procedures as needed. The committee will also discuss the implementation of the policy and procedures in the schools of the Issaquah School District. Each committee meeting will be open to the general public and will have a public comment period available at the beginning of each meeting. Notification of the meetings will occur at least two weeks in advance through a district initiated press release. The general public may get involved by attending the meetings and signing up for the public comment period that will be held at the beginning of each meeting.
