
# MILLAGE

# What is Millage?

- Millage Rate rate for determining property tax value
- 40% of property value taxed
- \$1 for each mil for every \$1,000 in assessed property value
  - 19.647 mills
  - Equal to \$19.647 for every \$1,000
- Exemptions

Property value (less exemptions) \* millage / 1000

# Reason for Millage Rate Increase FY19

Teacher Retirement System
 Employer Contribution Increase
 Set annually by TRS Board of Directors
 From 16.81% gross salary to 20.9%
 Additional Expense \$502,000

FY20 already set at 21.14%



# Reason for Millage Rate Increase

- Equalization funding decline for FY19
  - **(**\$457,320)
  - State Aid awarded to the district
    - Narrow the gap between systems
      - Property tax wealth per pupil
      - Based on system's effort to raise funds through property tax
      - Considered a "Reward for Effort" grant
      - If property wealth is increasing faster than the state average, school system receives less funds
      - Amount received is weighted and based data from other systems in the state



## Reason for Millage Rate Increase Additional Educators

- Primary 2 positions
  - Pre-K Teacher and Para-Professional –
  - Partly funded through General Fund
- Elementary -.5 position
  - Part-time EIP Teacher
- Middle 2.5 positions
  - Part-time Business Education
  - Science Teacher
  - Part-time Math Interventionist
  - Part-time 8<sup>th</sup> Grade Teacher

#### High – 2.5 positions

- Assistant Principal
- Math Teacher
- Part-time Math Instructional Coach

### Counseling Program

- MS & HS
  - Contracted with UGA
  - Assist students with college and career options
  - 8<sup>th</sup> 12<sup>th</sup> graders



### Reason for Millage Rate Increase

#### Administration – 2 positions

- Instructional Technology
- Full-time Assistant Superintendent
  - (vs. Two 49% positions)
- Full-time Special Education Director (vs. 49%)
- Full-time Assessment Director (vs. 49%)

### Benefits for New Full-Time Positions

- TRS
  - 20.9% of gross salary
- SHBP
  - \$11,340 annually



### Reason for Millage Rate Increase

### Improve School Safety

- School Resource Officer with County Support
  - Primary and Elementary
  - Additional officer totaling two full-time system wide


#### Millage Rates Surrounding Counties CY2018






