NOW THEREFORE, if the said _____ shall well and truly keep and perform, during said term, all the terms and conditions of the ordinances of the Town of West Hartford, regulating those activities for which the above-indicated licensure has been obtained; shall indemnify and save harmless the Town of West Hartford and the West Hartford Board of Education in the manner set forth in a Liability and Indemnity Agreement executed separately by the Principal; shall faithfully perform said work in all respects; shall guarantee his work for a period of one year after completion, against any failure caused by defective materials, or defective workmanship and will make good such defects, if so ordered, to the satisfaction of the Director of Community Services; shall comply in all respects with the rules and regulations established by the said Director relative to such work, and with the terms of the permits that may be issued to him; and shall also pay all fines imposed upon him for violation of any such rule or regulation, then this obligation shall be of no effect, otherwise, it shall remain in full force and effect, and the Surety shall, upon demand, satisfy any obligation of the Principal described above.
