Least Restrictive Environment

The district is looking to improve programming for students within the least restrictive environment 80% of the day or more and also to lower the percentage of students placed in other settings.
2. What universal practices does the district utilize to address the academic and social/emotional needs of all students in need of accommodations to their learning environments?
The district partners with our curriculum department to provide training on universal design for learning, also the IEP team reviews goals, psychoeducational evaluations and teacher and parent input when addressing the needs of the whole child. IEP teams discuss co-teaching options, increases in SDI and modifications to general education curriculum, inclusion of positive behavioral support plans, and additional adult supports to help with replacement behaviors for students to access general education settings. Additionally, teams have considered providing related services in the general education settings for student to access LRE.
3. Describe the academic programming and training efforts the LEA utilizes to ensure meaningful participation of students with disabilities in the general education curriculum.
The LEA is reviewing data and continuing partnerships with mental health and behavioral health organizations in order to develop behavioral supports in all settings. Administration is scheduling professional development and it is also working with IU and outside ABA providers to expand the hours and scope of practice within buildings. Academic and behavioral data are reviewed during faculty and department meetings, as well as weekly CARE meetings, PLT and PD days. Outside agency experts in Trauma Informed Care and Board Certified Behavioral Analysts share and disseminate information to district personnel via in-person trainings, and electronic sources.
4. Describe the supplementary aids and services the LEA utilizes to ensure meaningful participation of students with disabilities in extracurricular activities.
District will employ additional adult supports, if necessary, to ensure students have access to nonacademic or extracurricular activities. (Track, wrestling, bocce ball, Friday night games)
5. Describe the District procedures, which ensure that, to the maximum extent appropriate, children with disabilities placed in private institutions are educated with non-disabled children and have the opportunity to participate in district lead extracurricular activities?
The district maintains ongoing communication with the IEP team and counselors for students placed in private institutions to inform them of opportunities, auditions, tryouts, for any and all district lead extracurricular activities. This information is then discussed at both IEP meetings and separate conferences to maximize student participation.
6. Discuss the district's need to build capacity and expand programs and services in an effort to provide a continuum of services. (Consider the out of district placement chart)
The district needs to continue to review data and strengthen partnerships with mental health and behavioral health organizations in order to develop behavioral supports in all settings. Administration is scheduling professional development and re-alignment of the emotional support program with creation of an itinerant ES position with the eventual coordination and alignment for both elementary and secondary supports. District is also working with IU and outside ABA providers to expand the hours and scope of practice within buildings.

1. How does the district support the emotional, social needs of students with disabilities?

Any student who has been identified as having a behavior that interferes with his learning or the learning of others has a behavior plan to address this behavior in a positive systematic and consistent manner. Built into each plan is a reward system based on individual preferences. In addition, key people are identified in an effort to be a resource to the student in order to prevent negative behaviors from occurring. When a child has demonstrated the need for ongoing behavioral support, the IEP is revised to include additional supports and services and the behavior plan is updated as necessary. Part of our behavioral support program is to help children recognize the antecedent behaviors and develop communication skills to be able to ask for help, ask for a break, and to advocate for themselves in order to avoid negative behaviors from occurring.

2. Describe training provided to staff in the use of positive behavior supports, de-escalation techniques and responses to behavior that may require immediate intervention.

Staff are trained annually in non-violent crisis intervention techniques through Safety-Care training. This is conducted annually. Special education teachers receive training to develop FBA's and individual positive behavior support plans. Collection of meaningful data and identification of measurable and observable behaviors to monitor is emphasized. The Safety-Care program that is utilized by the district emphasizes a multi step process with least to most restrictive used as needed.

3. Describe the district positive school wide support programs.

Each year our professional development program in conjunction with our Behavioral Specialist Consultant provides the district professional development activities in the area of PBS. Each building has a PBS committee that meets on a regular basis to determine school wide positive behavior support programs within their respective buildings.

4. Describe the district school-based behavior health services.

The Colonial School District employs 4.5 FTE school psychologists. In addition to their primary responsibility of conducting evaluations, the school psychologists support the guidance department in providing individual and group counseling. In addition, the district employs a full time behavioral health adviser who meets with IEP teams and provides them with ongoing support to access community-based mental health services. In this way, students can receive services during the school day. The behavioral health adviser and other supports will help parents to identify community-based services available beyond the school day, if needed. There is also a contract with Lakeside Network and the Lincoln Center to provide on-site community counseling services through licensed professional counselors. Currently we have six full-time community counselors (1 for our K-3 buildings, 1 for the 4/5 building, 2 at our middle school, and 2 at our high school), most of whom are trained in Trauma Informed Care. Students in the CSD receive a wide range of related services as determined by the IEP team. The district consults and contracts with the MCIU and consults with PaTTAN to address all areas of student need. If there is a

service that a student needs to access his educational program that cannot be provided, the district will look beyond to private contractors. In order to assure the continuum of services, the district contracts for behavioral consultants whose duties range from writing FBA's to implementing behavior plans in conjunction with teachers. There are also contracts with outside agencies to provide Community Counselors (see above.) These counselors provide individual and group counseling for students who require this service.

5. Describe the district restraint procedure.

In a very small percentage of IEP's (less than 1%), it is documented in the present education levels that the use of restraint will be employed as a last resort in behavioral interventions. (Restraint is defined as any restriction of movement of a child against his or her will). After each restraint, an IEP meeting is held to modify the PBSP of the child, including the teaching of acceptable replacement behaviors. The goal of each behavior plan is to promote positive behaviors, and to eliminate negative responses, therefore lessening the possibility of the need for restraints. Ongoing monthly check ins are held around utilization of less restrictive means.

Intensive Interagency

The LEA conducts a documented interagency meeting to discuss the student's needs and program elements. Colonial works with local out of district placements to locate placements that are appropriate for these students as well as determine the need for Instruction Conducted in the Home while determining an appropriate placement to deliver FAPE. The Coredero process was completed for the only student fitting this criteria during the past school year.
