District Improvement Plan Goals for 2022-2023

By June 2023, increase achievement on state assessments in the area of ELA by 3 percentage points.

By June 2023, increase the percentage of students on track to graduate by 2 percentage points at the high school level and decrease the percentage of students in Tiers 2 and 3 by 2 percentage points.

In support of strengthening student academic achievement, New Holland Knowledge Academy receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by section 1116(b) and (c) of the Every Student Succeeds Act (ESSA). The policy establishes the school's expectations for parent and family engagement and describes how the school will implement a number of specific parent and family engagement activities, and it is incorporated into the school's plan submitted to the local educational agency (LEA).

New Holland Leadership Academy agrees to implement the following requirements as outlined by Section 1116:

JOINTLY DEVELOPED

ANNUAL TITLE I MEETING

RESERVATION OF FUNDS

New Holland Knowledge Academy will take the following actions to involve the parents of children served in Title I, Part A schools in decisions about how the 1 percent of Title I, Part A funds reserved for parent and family engagement is spent by:

- Meet with the School Governance Council to review the budget and to determine areas of need regarding Parent Resource Room purchases and the purchase of materials to aid parents when working with students at home
- PFE funds for fiscal year 2022 have been consolidated. This allows the school to have more flexibility with how funds are prioritized and expended.

COORDINATION OF SERVICES

The Gainesville City School System will integrate Parent and Family Engagement programs in Part A with parent and family engagement strategies under the following programs: Pre-K, Homeless, Neglected and Delinquent, Special Education, Migrant, and other district programs by:

- Offering preschool at New Holland Knowledge Academy and providing preschool for students with special needs
- Providing resources needed for school to host Parent and Family Engagement sessions so parents learn ways to support their child at home
- Provide materials to parents and families for at-home use throughout the Parent Resource center.
- GCSS Migrant staff members provide tutorial services in the home for preschool aged children, as well as, provide materials to help parents prepare children for school. *GCSS Migrant staff members make every attempt to help get migratory pre-K children enrolled in a formal pre-K program if at all possible (this includes GCSS pre-K program, as well as others in our community*

BUILDING CAPACITY OF PARENTS

New Holland Knowledge Academy will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

- Providing parents with a description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress, and the achievement levels of the challenging State academic standards
- Materials and training to help parents to work with their child to improve their child's achievement, such as literacy training and using technology
- Providing assistance to parents of participating children, as appropriate, in understanding topics such as the following:
The challenging State's academic standards, state and local academic assessments including alternate assessments, requirements of Title I, Part A, how to monitor their child's progress, how to work with educators to improve the achievement of their child
- Send home quarterly progress reports and report cards
- Provide parent information and resources on the school's website
- Utilize automated calls and text messages to inform families of school information
- Provide a student handbook and agenda to each student
- Utilize translator/interpreter for school events

BUILDING CAPACITY OF SCHOOL STAFF

New Holland Knowledge Academy will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

- Meet monthly with our School Governance Council to garner feedback for topics of improvement
- Conduct weekly Professional Learning Community meetings with teachers
- Monitoring and effectively notifying parents of student attendance
- *Curriculum nights for each grade level to include grade level presentations*
- Send information home in the child's home language
- *Building ties between parents and the school through extracurricular and academic programs*

- *Using the school website to list resources and use it as an avenue for communication between parents and the school*

BUILDING CAPACITY FOR INVOLVEMENT

New Holland Knowledge Academy will provide other reasonable support for parent and family engagement activities under Section 1116 as parents may request by:
