1. Superintendent News

Superintendent Cash shared with the Board that we held our third annual ELF (Educators Loving Families) program on Tuesday, December 18th. District Administrators took a student to Walmart for Christmas and paid for the gifts out of their own pocket. We held our second annual Christmas dinner on Wednesday, December 19th. Staff enjoyed the fellowship and dinner. Bus Drivers and Bus Monitors were able to enjoy their dinner at the 10:30 am meal before starting their afternoon routes for Christmas break. He shared with the Board that our Preschool students were number one in the State for Kindergarten readiness. We are very proud of our Pre-Teachers and staff. Superintendent Cash thanked Brandon Kidd, Board Chairman and Rhonda Armijo, Board Member for their service. Some of the accomplishments under their service were: test scores are higher than they've ever been, we have more SEEK funds available for instructional use, school district facilities are state of the art. He thanked them for putting Kids first and for caring for our Kids. He presented them with a plaque commemorating their years of service with the McCreary County School District. Rhonda Armijo shared that it has been an honor to serve the McCreary County School District and that she is most proud of serving the
