- The Legislature is working on the next Biennium Budget for Fiscal Years 20-21. The final budget is due in June. It is a complicated formula which Speaker of the House Householder wants to simplify.
- Representatives Bob Cupp and John Patterson have been holding reginal meetings discussing recommendations to change the Funding Formula.
- One area of concern is the funding for transportation for schools by the state. It continues to be an area cut in recent years.

• The Governor has proposed an increase in the amount for highways and roads. The gas tax will be increased by .18 cents per gallon.
